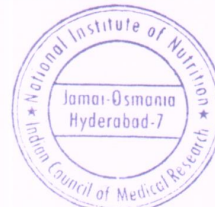

Applications received after due date will not be considered under any circumstances. The candidates have to download the application form from [www.nin.res.in](http://www.nin.res.in) and fill it with his/her own handwriting and send the same to the above mail along with supporting documents of essential qualifications (**scanned copies**).

**Selection Procedure:** After verification of the applications, the names of eligible candidates list will be displayed on the official website [www.nin.res.in](http://www.nin.res.in). The applications are shortlisted for the interview based on the decision of the selection committee as per the project requirements. Interviews will be conducted for the shortlisted candidates through online (Video call/ Video-Conferencing) to select suitable candidate in later course. The candidates have to make their own arrangements for Video Call/ Video-Conferencing facilities for Online Interviews. The link will be sent to the shortlisted candidates for online interviews. The applicants are advised to visit our website regularly for any updates and changes in the recruitment process.

**Terms and conditions:** 1) The above positions/posts are on temporary contract basis. 2) The Director & Appointing Authority has the right to accept/reject any application without assigning any reason(s) and no correspondence in this matter will be entertained. 3) \*Age relaxation is admissible in respect of Retrenched Government Employees, Departmental Candidates (including projects) and Ex-Servicemen in accordance with the instructions issued by the Central Government from time to time. Age concession to the extent of service rendered in other research projects will also be admissible for experienced and skilled persons. Age, qualifications, etc., will be reckoned as on the last date of receipt of applications. 4) The appointment can be terminated with one-month notice from either side without assigning any reason. 5) Since, the posts are temporary; the incumbents selected will have no claim for regular appointment at ICMR-NIN or continuation of his/ her services in any other project. 6) Other allowances like CCA, LTC, Medical Claim and PF are not applicable. 7) The results of the final selection will be placed on NIN website only.
