Reference advertisement No: ICMR/Assistant/2020.

Kindly refer to the advertisement as mentioned above. The following are added under para-3 & 7 :

- (i) Para -3 (application fee for Ex-servicemen) – application fee is payable of Rs.1200/- plus transaction charge as applicable.
- (ii) Para-7 (age relaxation for ex-servicemen) – In pursuance of compendium of instruction for ex-servicemen issued vide O.M.36034/3/2013-Estt. (Res.) dated 25.2.2014, the upper age limit is relaxed by the length of military service increased by 03 years in the case of ex-servicemen and commissioned officers including Emergency Commissioned Officer of Short Service Commissioned Officers.
 - (a) On completion of assigned (including those whose assignment is due to be completed within one year) otherwise than by way of dismissal or discharged on account of misconduct or inefficiency or
 - (b) On account of physically disability attributed to military service or on invalidment shall be allowed maximum relaxation of 5 years in the upper age limit.
 - (c) The applicants seeking age-relaxation under this category shall invariably submit the requisite certificate as per the Appendix-2 & 3 enclosed with O.M. No. 36034/2/91-Estt. (SCT) dated 03.04.1991 issued by DoPT.
