- 2. Incomplete applications, application not submitted in prescribed format and application without supportive documents shall be summarily rejected.
- 3. Qualification and experience should be in relevant discipline/field and from a reputed institution / organization recognized by relevant authority.
- 4. Experience shall count from the date of acquiring minimum educational qualification.
- 5. Submission of incorrect or false information during the process of walk-in- written test and / or personal discussion shall disqualify the candidature at any stage.
- 6. The Director reserves the right to increase / decrease the number of vacancies as per requirement.
- 7. Candidate should write/tick mark the **Name of Project on the top of the application.** Candidates applying for more than one post should apply **SEPARATELY** for each post.
- 8. No benefit of provident fund, Leave Travel Concession, Medical Claim etc. will be considered, since the posts are purely temporary basis.
- 9. Age relaxation to SC/OBC against post earmarked for reserved category will be considered as per Govt. of India Norms. Age relaxation to Ex-Service Man /Departmental candidates including projects works to be considered as per rules of ICMR.
- 10. Age limit and experience will be considered as on the date of walk-in- written test and / or personal discussion.
- 11. No TA/DA will be paid for attending the walk-in- written test/ personal discussion.
- 12. Candidates employed in Govt. Service /Semi Govt./ Autonomous Bodies of State/Central Govt. should submit a "No Objection Certificate" from their employer at the time of walk-in- written test and / personal discussion failing which he/she will not be allowed to appear in written/personal discussion.
- 13. Written test, if required will consist of objective and multiple type questions based on syllabus as per the essential qualification. If the reported eligible candidates are more than 30, the written test will be held followed by personal discussion otherwise direct personal discussion will be held from the time of written test indicated onwards

- 14. Community/ Caste certificate: Candidates applying under OBC category shall submit attested copy of OBC Non Creamy Layer Certificate in specified format, issued within one year from the date of walk-in-written test and / or personal discussion by the appropriate authority. Only Non Creamy Layer OBC certificates will be accepted and other certificates will not be accepted.
