Indian Council of Medical Research is a premier autonomous medical research organization under the Department of Health Research (DHR), Ministry of Health and Family Welfare, Government of India, dealing with health research in various areas in collaboration with national/international agencies through its 26 Institutes/Centres and a large number of field stations situated all over the country.
- 3. The post is with all India transfer liability under the Council.
- 4. <u>Duration of the contract</u>: The period of contract shall be five years from the date of commencement, extendable upto a maximum of two years depending upon outstanding performance.

#### 5. <u>Essential Qualification & Experience</u>

- (i) Postgraduate degree in medical subjects recognized by MCI or Doctorate degree in Life/Biological Sciences or relevant subjects from a recognized University.
- (ii) Sixteen years R&D experience in the relevant areas in a recognized Institute(s) after obtaining essential qualification, out of which at least 5 years in a managerial position to handle R&D projects independently, in a team effectively in directing position including 2 years regular service in Grade Pay of Rs.8900/-.

#### 6. <u>Desirable Qualification</u>:

- (i) Additional Post doctoral research/teaching experience in relevant subjects after MD/Ph.D in recognized Institute(s)
- (ii) Knowledge of Computer Applications or Business Intelligence tools/Data Management

#### 7. Age limit:

Between 45 years to 58 years. The crucial date for determining the age limit shall be as per the guidelines of Department of Personnel and Training issued from time to time. However, the prescribed age may be relaxed in exceptional cases for experienced and qualified candidates by DG, ICMR.

Application Fee of Rs.500/- (Rupees five hundred only) is required. SC/ST/Women/PWD candidates are exempted from application fee. Application Fee is to be paid by candidates through Crossed Demand Draft (DD) in favour of Director-General, ICMR, payable at New Delhi.

## 10. Other conditions:

- (i) Application received after the closing date for whatever reason is liable to be rejected.
- (ii) In the event of any false information furnished or suppression of any material in the application coming to notice at any time during the service of a person, his/her services would be liable to be terminated.
- (iii) Application unsigned/incomplete or without supportive documents is liable to be rejected.
- (iv) The application from employees working in Centre/State Government Department/ Public Sector Undertakings & Govt. funded research agencies must be forwarded through proper channel along with the certificate of the employer that "the applicant will be relieved within three months of his/her receipt of appointment order". Advance copies of application will be considered subject to the condition that a 'No Objection Certificate' from the employer is produced at the time of personal discussion.
