Candidates are invited to attend a Walk-in-Interview/Written Test on 4th July 2019 for the following post to be filled purely on temporary basis under the project entitled "Data Management Unit of Implementation Research" under National Mental Health Programme under Dr. Harpreet Singh, Informatics, System and Research Management (ISRM), ICMR HQRS, New Delhi-110029.

The Terms & Conditions for the post are as follows:

a) Scientist-D - Unreserved (1 posts) (Rs.67,000/- pm + HRA)

Candidates must bring 5 copies of CV along with all original certificates of educational qualifications (from SSC onwards), experience, Aadhaar Card and Community Certificates along with one set of photocopies of the same duly attested (can be self-attested) along with two passport size photograph for attending the Written Test/Interview. The Registration time is from 9.30 AM to 10.30 AM on 04.07.2019. After 10.30 AM not any candidate allowed to attend the walk-in-interview.

1. Candidates who fail to bring the Original Certificates for written test / Interview will not be considered.
2. The post is to be filled up on purely temporary basis and will be initially for a period of one year.
3. The appointment can be terminated with one month notice from either side without assigning any reason.
4. Since the post is purely temporary, the incumbents selected will have no claim for regular appointments under ICMR or continuation of his/her services in any other project.
5. Benefits of Provident fund, CCA, Leave Travel Concession, Medical claim etc. are not applicable.
6. No Age relaxation against the Unreserved vacancies as per Govt. of India order No.36011/1/98/Estt(Res) dated 1/7/1998.
7. No TA/DA etc. will be given to attend the Interview or joining of post and candidate should make his/her own arrangement for stay for the interview and joining of the post.
8. Qualification and experience should be from a reputed organization.
9. The experience will be counted only after completion of minimum educational qualification.
10. Mere fulfilling the essential qualification does not guarantee for the interview call and selection.
11. Canvassing in any form will be a disqualification.
12. Persons already in regular time scale service under any Government Department/ Organizations are not eligible to apply.
13. Consolidated salary of post may be revised as per ICMR instructions.
14. PhD or MD degree in subjects relevant to Indian Council of Medical Research shall be treated equivalent to three years of experience respectively. The selected candidates will work in the project mentioned above and on any other work that may be assigned by the Principal Investigator from time to time.

OR

- MBBS degree recognized by MCI or equivalent degree from recognized university with 8 years R&D/teaching experience in the mental health and related discipline after MBBS Degree.

Desirable Qualification/ Experience:

- MD in the Mental Health and related discipline from a recognized university for candidates with a first class relevant degree.
- Additional Post-doctoral research/teaching experience in Mental Health and related discipline in recognized institute(s).


Age Limit:

- Not exceeding 45 years. No Age relaxation against the Unreserved vacancies as per Govt. of India order No.36011/1/98/Estt(Res) dated 1/7/1998.

1. MD/MS/MDS/PhD in the relevant subject shall be treated equivalent to three years of experience.
2. Postgraduate Diploma in medical subjects in the Mental Health and related discipline shall be treated equivalent to two years of experience.
