The ICMR-Vector Control Research Centre (ICMR-VCRC), Puducherry is a Permanent Institute of Indian Council of Medical Research, an autonomous organization under the Department of Health Research, Ministry of Health & Family Welfare, Government of India, invites applications upto **08.04.2019** for filling up the following vacancies in ICMR-VCRC, Puducherry and its Field Stations in different parts of the Country on All India Service Liability;

**Job requirements:-****Sl. No. 1:**

Planning and execution of research programmes that include both field and laboratory components, related to vector borne diseases and their control in different eco-epidemiological settings, focusing on vector control through integrated vector management approach and evaluation of vector control tools. Any other relative research on vector control and vector borne diseases.

**Sl. No. 2:**

Planning and execution of research programmes related to development of new techniques / products for the control of vectors and vector borne diseases. Standardization of analytical methods for insecticides / drugs using spectrophotometric and HPLC techniques. Any other relative research on control of vectors and vector borne diseases.

**(Please read the following instructions carefully)**

**ABBREVIATION :** SC – Scheduled Caste, ST – Scheduled Tribe, OBC – Other Backward Classes (**Non-creamy layer**), PwD – Person with Disabilities, UR – Unreserved, XSM – Ex-Servicemen

**Age Limit:**

Crucial date for determining the age limit will be the closing date for receipt of application, i.e., **08.04.2019**. Relaxable upto 5 years for Government servants, SC/ST/PwD candidates & Ex-servicemen and 3 years for OBC candidates or in accordance with the instructions and orders issued by the Department of Personnel & Training (DoPT) from time to time in this regard.

One time age relaxation is also allowed to Scientific and Technical staff working in long term projects in ICMR Institutes/Centres, provided they meet essential qualifications and experience for the post with a view to provide them an opportunity to compete with other candidates as per provision made under HRSC Rule 2007 as amended from time to time, vide Council's letter No. 6/1/2007-Admn.II dated 28.03.2011. Those who avail one time age relaxation should give an undertaking stating that he/she avails one time age relaxation for the first time.

**General Relaxation Clause:**

Age, qualification and experience will be relaxable in deserving cases as mentioned in the Recruitment Rules of Health Research Scientists Cadre of ICMR, 2007 under Rule 14 and Note 1 & 2 of Schedule-III.

**How to apply:**

- (1) Application form and other information may be downloaded from the websites "[www.icmr.nic.in](http://www.icmr.nic.in)" and "[www.vcrc.res.in](http://www.vcrc.res.in)" on or before the closing date.
- (2) Demand Draft for ₹ 500/- (**Rupees Five Hundred Only**) towards application fee drawn in favour of "**The Director, ICMR-VCRC, Puducherry**" to be submitted along with duly filled-in application. SC/ST/PwD and Women candidates are exempted from payment of application fee. **ICMR employees are not exempted** from payment of application fee. Candidates, who wish to apply for more than one post, have to submit separate application for each post along with Demand Draft (as applicable).
  - (i) On the over leaf of Demand Draft, the candidate must mention his/her name and post applied for & discipline.
  - (ii) Application fee once paid will not be refunded under any circumstances nor can it be held in reserve for any other recruitment or selection process.
  - (iii) Any other mode of payment viz., cash, money order and cheque will not be accepted.
- (3) Application form duly signed by the candidate with enclosures along with Demand Draft (as applicable) should be sent to "**The Director, ICMR-Vector Control Research Centre, Medical Complex, Indira Nagar, Puducherry – 605 006**", so as to reach on or before 08.04.2019.
- (4) Self-attested copies of the following documents should be enclosed along with the application form:-
  - (a) Proof of Date of Birth
  - (b) Educational qualification (Degree / Diplomas/certificates and copies of all mark sheets for all the years)
  - (c) Experience (proof for all experiences mentioned in the application)
  - (d) Community Certificate (as applicable)
  - (e) Self declaration for OBC candidate (Refer to Annexure "C")
  - (f) Demand Draft for ₹ 500/- (wherever applicable)
  - (g) Other documents, as applicable
  - (h) List of publications with impact factor

- (5) Candidates belonging to reserved category (SC/ST) should submit the community certificate issued by the competent authority in the prescribed format (**Annexure "A"**) of Government of India for claiming age relaxation / fee concession.
- (6) In case of candidates belonging to OBC category, community certificate should specifically contain the clause that the candidate does not belong to "**CREAMY LAYER**" section. The OBC candidate who belong to CREAMY LAYER are not entitled for reservation admissible to OBC category and such candidates have to indicate their category as General. The OBC (Non-Creamy Layer) candidates should submit the community certificate issued by the competent authority in the prescribed format (**Annexure "B"**) of Government of India for claiming age relaxation. In addition to the community certificate, the OBC candidates are required to submit their self-declaration in the prescribed format (**Annexure "C"**) that they belong to backward class recognized by Government of India and also they do not belong to persons/sections/sections (creamy layer) as per DoPT O.M dated 08.09.1993, 09.03.2004 and 14.10.2008.

**Other service conditions:-**

- (1) Allowances as per Central Government Rules are admissible on the pay scale mentioned against each post.
- (2) Benefits of new restructured defined contributory pension system are admissible as per the provision contained in the Ministry of Finance, Department of Economic Affairs (ECD & PR Division), Notification No. 5/7/2003-ECD & PR dated 22.12.2003 effective from 01.01.2004.
- (3) Applications from employees working in Central / State Government Departments / Public Sector Undertakings / Government funded research agencies must be forwarded through proper channel. Advance copy of application with all necessary documents will be considered subject to the condition that "**No Objection Certificate**" from the employer is produced **at the time of certificate verification**. Applications received after the last date, will not be considered.
- (4) The selection to the above posts shall be made by open competitive written test followed by Interview/Personal discussion.
- (5) Appointment will be subject to medical fitness and verification of character and antecedents from civil authorities.
- (6) The above posts are with all India transfer liability under the Council.
- (7) Date, Time and Place of written test and Interview/Personal discussion will be intimated to the eligible candidates through post, separately.
- (8) The Centre will not be responsible for any post delay.
- (9) Incomplete / late applications or without application fee (except for the exempted candidates) or applications without signature and copies of required certificates will be summarily rejected without any notice and no enquiry in this regard, will be entertained.
- (10) The notified vacancies are tentative. The ICMR-VCRC reserves the right to cancel / restrict / enlarge / modify the requirements advertised, if need, so arise, without assigning any further notice or assigning any reason thereto. The decision of the Director, ICMR-VCRC, Puducherry, will be final.

- (11) While applying for the above posts, the candidate must ensure that he/she fulfils the eligibility and other terms and conditions mentioned as on the specified dates and the particulars furnished are correct in all respects. In case it is detected at any stage of recruitment/selection that the candidate does not fulfil the eligibility norms and/or that he/she has furnished any incorrect/false information or has suppressed any material fact(s), his/her candidature will automatically stand cancelled. If any of the above shortcoming(s) is/are detected even after appointment, his/her services are liable to be terminated without any notice.
- (12) The ICMR-VCRC reserves the right to rectify any inadvertent error or omission at any stage of the recruitment process.
- (13) Merely satisfying the essential qualification and experience does not entitle the candidate to be called for written test/interview.
- (14) Certificate(s) of experience should clearly mention the designation, duration (date, month and year), the basic pay and/or consolidated salary and the nature of duties performed and experience obtained in the employment.
- (15) The period of experience in a discipline/area of work, wherever prescribed, shall be counted after the date of acquiring the minimum educational qualifications prescribed for that post.
- (16) The period of experience rendered by a candidate on part time basis, daily wages, visiting/guest faculty etc., will not be counted while calculating the valid experience for shortlisting the candidates for interview.
- (17) Since it is not possible to call all the eligible candidates for the written test, the candidates will be shortlisted for this purpose. The decision of the Director, ICMR-VCRC will be final in this regard.
- (18) SC/ST candidates called for interview/personal discussion will be paid 2<sup>nd</sup> class rail fare by the shortest route, subject to production of documents along with proof of travel. Local transportation charges shall however be borne by the candidates themselves. Candidates will make their own arrangements for boarding and lodging.
- (19) Canvassing by or on behalf of the candidates or to bring political or other outside influence with regard to selection/recruitment shall be a disqualification. No enquiry or correspondence shall be entertained on the issue related to selection process.
