1. Age Limit:

- i. For Scientist "B" Posts: Not exceeding 35 years for Scientist "B" Post. Relaxable upto 5 years for Government Servants & SC/ST and 3 years for OBC candidates and 10 years for Physically Handicapped (PH) candidates in accordance with instructions issued by Department of Personnel and Training from time to time and subject to the condition that maximum age of the applicant on the crucial date shall not exceed 56 years. Economically weaker Section (EWS) reservation will be considered as per DoPT OM dated 31-01-2019 subject to the production of Income Certificate (Format attached)
- ii. One-time age relaxation is also allowed to Scientific and Technical Staff working in long term projects in ICMR Institutes/Centres for posts advertised under HRSC-2007 provided they meet essential qualifications and experience for the post with a view to provide them opportunity to compete with other candidates as per Council's letter No.6/1/2007-Admn.II dated 28.3.2011
- iii. General Relaxation clause: Age, Qualification and Experience will be relaxable in deserving cases as mentioned in the Recruitment Rules of Health Research Scientists cadre of ICMR, 2007 under Rule 14 and Note (i) & (ii) of Schedule III.
- iv. Age will be reckoned as on last date of the receipt of application ie., 14-03-2019.

2. Other Service Conditions:

- i. Allowances as per Central Government Rules are admissible on the above mentioned pay scale
- ii. Benefits of new restructured defined contributory Pension system are admissible as per the provision contained in the Ministry of Finance, Department of Economic Affairs (ECB & PR Division), Notification No.5/7/2003-ECB & PR dated 22.12.2003 effective from 1.1.2004.
- iii Applications from employees working in Central/State Govt. Departments/Public Sector Undertakings and Govt. Funded research agencies must be forwarded through proper channel. Advance copies of application will be considered subject to the conditions that a 'No Objection Certificate' from the employer is produced at the time of written test / personal discussion. Application received after the closing date will not be considered.
- iv. Private practice is not allowed, however, non-practicing allowance is admissible to medical / veterinary graduates only as per rules.







3. Application fee:

- i. Demand Draft of Rs.500/- (Rupees five Hundred only) payable in favour of "The Director, NIN, Hyderabad" should be enclosed alongwith application and should reach to this office on or before closing date. The SC/ST/Women/physically handicapped candidates (PH) are exempted from the application fee. All other / ICMR employees are not exempted from the payment of application fee.
- ii. On the over leaf of demand Draft, the candidate must mention his/her name and post applied.
- iii. Fee once paid will not be refunded under any circumstances.
- iv. Any other mode of payment viz. cash, money order and cheque will not be accepted.

4. How to apply

- ii. The application may be preferably submitted in the standard application format
 - a) The filled in application duly signed by the applicant should be submitted to The Director, ICMR-National Institute of Nutrition, Jamai Osmania (PO), Hyderabad-500007, alongwith self-attested copies of the certificates
 - b) Proof of Date of Birth (Cut of date for Age criteria will be date of notification)
 - c) Educational qualification
 - d) Experience certificates/testimonials
 - e) List of Publications mentioning clearly the 'Name of the Journal' and 'Impact Factor'
 - f) One-self attested recent passport size photograph
 - g) ID Proof (Ex. Aadhar Copy PAN/Voter ID/Driving License etc.)
 - h) One set of self-attested photocopies of all documents
 - i) Application fee in the form of Demand Draft
- iii. Last Date for submitting completed applications is 14th March, 2019 upto 5:30 pm

5. Selection Procedure:

The applications received will be screened at Level-1 by a Screening Committee as per the criteria adopted by ICMR. The candidates found eligible on the basis of the recommendation of Level-1 screening committee will be invited to appear for the written examination (objective type).

The candidates will be called for personal discussion / interview (as per the rules of the ICMR) on the basis of merit of the marks obtained in the written test and CV scrutiny i.e., marks for publication, experience, awards, etc. The final decision for selection will be based on the criteria adopted by ICMR.







SCORING CRITERIA

- I. Written Test (Maximum marks 40): The written test would be of 100 marks consisting of 100 objective/ MCQ type questions of one mark each for the correct answer. The final score will be computed for a maximum of 40 marks based on the marks obtained in the written test of 100 marks. For each wrong answer 0.25 marks will be deducted. Out of 100 questions, 90 questions will be objective/ MCQ type and 10 objective/ MCQ for analytical skills.
 - a. Level of guestions will be based on essential qualification mentioned against each post
 - b. Questions will cover all the areas mentioned below:-
 - 1. Areas of relevant subject specified against each post
 - 2. Computing skills
 - 3. General Scientific knowledge
 - 4. Current Affairs including developments in Biomedical Sciences
 - 5. Common sense
 - 6. Institute specific areas
 - 7. Post specific areas
 - 8. Fundamental knowledge
 - 9. Subject specific knowledge
- II. Publication, experience etc (Maximum marks 20)
- III. Personal discussion / Interview (Maximum marks 40)

6. General Instructions:

- i) Ph. D degree in relevant subject shall be treated equivalent to three years' experience. Candidates with Ph.D. degree will be preferred for direct recruitment.
- ii) Candidates called for personal discussion will be paid a 2nd Class rail fare by the shortest route, subject to production of documents alongwith proof of travel. Local transportation charges shall however be borne by the candidates themselves.
- iii) The post is with all India transfer liability under the Council.
- iv) The envelope containing applications should be super scribed Application for the post of 'name of the post & post no.'
- v) Candidates are directed to submit the caste certificate in prescribed format issued as per Government of India instruction by the competent Authority for appointment to posts under Government of India, which shall not be more than one year-old from the date of publication of this advertisement.
- vi) Applications from employees working in Central/State Govt. Departments/Public Sector Undertakings and Govt. Funded research agencies must be forwarded through proper channel. Advance copies of application will be considered subject to the conditions that a 'No Objection Certificate' from the employer is produced at the time of written test / personal discussion. Application received after the closing date will not be considered.
- vii) Unsigned/incomplete applications or applications without supportive evidence, without application fee (in the form of Demand Draft), applications received late, shall be summarily rejected.
- viii) ICMR-NIN, Hyderabad will not be responsible for any postal delay/wrong delivery.







- ix) Since it is not possible to call all the eligible candidates for the written test, the applications fulfilling essential qualification and experience will be shortlisted. Only shortlisted candidates will be called for written test and no correspondence will be entertained in this regard.
- x) Date of written test / personal discussion will be communicated to the eligible candidates through call letters only and no enquiry in this regard will be entertained.
- xi) No TA will be admissible to attend the written test.
- xii) Canvassing by or on behalf of the candidates or to bring political or other outside influence with regard to selection / recruitment shall be treated as disqualification
