1. Age Limit

- i. Not exceeding 35 years for SC Category candidates against the reserve post for SC as on the last date mentioned above.
- ii. Person working in ICMR projects continuously shall also be eligible for age relaxation upto five years provided he/she entered into project service within prescribed age limit for the post.

2. Other Service Conditions:

- i. Allowances as per Central Government Rules are admissible on the above mentioned pay scale
- ii. Benefits of new restructured defined contributory Pension System are admissible as per the provision contained in the Ministry of Finance, Department of Economic Affairs (ECB & PR Division), Notification No.5/7/2003-ECB & PR dated 22.12.2003 effective from 1.1.2004.
- iii. Applications from employees working in Central/State Govt. Departments/Public Sector Undertakings and Govt. Funded research agencies must be forwarded through proper channel. Advance copies of application will be considered subject to the conditions that a 'No Objection Certificate' from the employer is produced at the time of written test. 5. <u>Selection Procedure:</u>

All the eligible candidates will be called for the written test. The written test would be of 100 marks consisting of 100 objective/ MCQ type questions of one mark each for the correct answer. For each wrong answer 0.25 marks will be deducted. Out of 100 questions, 90 questions will be objective/ MCQ type and 10 objective/ MCQ for analytical skills.
