General Terms and conditions:

1. The shortlisted candidate shall join **within 7 days** of declaration of result on the ICMR website.
2. No TA/DA will be paid to the shortlisted candidate for joining, they have to arrange transport / accommodation themselves.
3. The rates of emoluments/stipend mentioned in the project advertisement are project specific and may vary according to sanction of the funding agency of the Project.
4. Successful candidates will normally be engaged on Project Human Resource Position initially for a period of one year or less, depending upon the tenure of the Project and functional requirements. Continuation / Extension to engagement of Project Human Resource Positions will be depending upon evaluation of performance, tenure of the project (3 years), availability of funds, functional requirements and approval of Competent Authority. The maximum term of any Project Human Resource Position in any or multiple projects, with breaks or without breaks shall be five years only. The concerned Project Investigator, Division Head and Head of the host Institute shall personally be responsible and accountable for the continuation / extension given if any without prior concurrence of the Director General, ICMR to any project human resource position beyond five years either with or without breaks in any or multiple projects.
5. ICMR reserves the right to terminate the project human resource position even during the agreed contract period or extended contract period without assigning any reason.
6. Leave shall be as per the ICMR's policy for project human resource positions.
7. Shortlisted candidate may provide the original documents and a copy of self-attested documentation proof of educational qualification, working experience, age and photo id at the time of joining.
