The following proposal was presented before the Executive Council of ICMR, in its 16th meeting held on 22-01-2024, for amendment of Recruitment Rules of Assistant post, in column no. 10 of the RR:

The EC has recommended that the minimum regular service required in the post of UDC to be eligible for appearing in the LDCE (Limited Departmental Competitive Examination) method should be 5 years. However, w.r.t the quota for promotion, the EC has recommended to consider the percentage of LDCE method to 20 %, instead of 10%, as per the prevailing RR dated 09-12-2020, in consultation with the concerned stakeholders.

The stakeholders of ICMR Administrative Cadre are hereby directed to provide their inputs/ suggestions, only on the percentage of LDCE quota (whether 20% or 10 %), through email at admn2355@gmail.com, on or before 15-03-2024 (Friday). No more communication in this regard will be considered beyond the stipulated time.
