With the approval of Competent Authority, the Guidelines of ICMR-Adjunct Faculty program has been revised*. The details are given below:-

3.	Age Criteria: No age bar	Age criteria: Max. age limit is 65 years (at the time of application).

4.	Tenure: Three months at a time for two more terms, i.e. total of nine months	Tenure: Initially the tenure will be for one term i.e. three years. It may be extended for another term of three year based on the outcome of the collaborative efforts/activities carried out.
5.	Place of work: Not specified	Place of work: The Adjunct Faculty will continue to work in their host institute. They are required to spend at least two weeks every year continuously at ICMR, the duration can be extended on case to case basis with due approval by the Competent Authority of ICMR.
6.	Remuneration: Monthly honorarium of Rupees one lakh consolidated plus Rs. 20,000/- for attending meetings.	Remuneration: There is no provision of honorarium for the Adjunct Faculty. However, the Adjunct Faculty will be given Daily Subsistence Allowance (DSA) @ INR 2000/- for the duration of stay at ICMR/ICMR Institutes/Centres.

Evaluation of progress Report: Annual work done is reviewed by the Expert Committee constituted by DG, ICMR	Evaluation of progress report: Annual performance review of the adjunct faculties will be done by Director of the linked ICMR Institutes and after the three year tenure review of performance will be done by the Selection Committee at ICMR Headquarters.
