This is in continuation to this office letter of even number dated 19/09/2023, where in, the existing JRF/SRF under the ICMR funded projects, were re-designated and emoluments revised to that of Project Research Scientist-I(Medical/Non-Medical), subject to minimum essential qualification and age of Project Research Scientist-I (Medical/Non-Medical) in term of OM dated 01/08/2023.

In line with the above, it has been decided that the Research Associates-I/II/III who are also presently working in the ICMR funded projects, shall also be re-designated and emoluments revised to that Project Research Scientist (Medical/Non/Medical), on the same terms of OM dated 01/08/2023, subject to having the minimum essential qualification and age of Project Research Scientist, as follows:

Research Associate having less than 3 years experience after M. Sc	Project Scientist-I
Research Associate having more than 3 years experience after M. Sc	Project Scientist-II
Research Associate having more than 3 years experience and having worked at least 5 projects	Project Scientist-III

Henceforth, JRF/SRF and Research Associates shall not be recruited under any of the ICMR funded projects (Extramural/Intramural). Fellowship positions shall be sanctioned only as per the ICMR letter 26/10/2023. The present incumbents shall stand relieved on completion of current tenure and no further extension shall be continued.
