Sr. No.	Technical Specifications / Scope of supply	Compliance	Remarks (to provide details)
1	Inner chamber size required: Width: 3.5 feet; Height: 4 feet; and Depth: 7 feet. (Approximately 1050 mm width x 1200 mm height x 2100 mm depth).		
2	This steam sterilizer is for use in Primate quarantine facility, for sterilization of cages, each cage of size 900 mm width x 1000 mm height x 900 mm depth, each cage weighing 125 kgs approximately;		
3	The sterilizer should be of 'pit-mounted' type, so that the bottom portion of the inner chamber should be as nearer to the finished floor level of the installation site. This is to enable the "Cage racks to be moved directly into the inner chamber'.		
4	Suitable lifter / loader to be supplied along with the sterilizer, to enable the cages to be loaded and unloaded manually using the lifter / loader;
