Subject: Payment of Additional quantum of pension/family pension to pensioner/family pensioners of 80 years of age and above

As the Institutes are aware that currently all cases of payment of additional quantum of pension/family pension to pensioners/family pensioners of 80 years of age above are being submitted to the Headquarters for approval, consequent to the receipt of an application from the concerned pensioners/family pensioner.

- 2. The matter has been reviewed and it has been decided that henceforth Institute will make payment of additional pension automatically on attaining the age of 80 year or above, as mentioned below, with the approval of the Director under intimation to pension cell of ICMR (HQ) in the following manner:-
- (i) The additional quantum of pension /family pension after attaining the age of 80 year and above would be admissible at the below mentioned rates:-

Age of Pensioners/ Family Pensioners	Additional quantum of Pension/ Family Pension
From 80 Years to less than 85 Years	20% of Basic Pension/Family Pension
From 85 Years to less than 90 Years	30% of Basic Pension/Family Pension
From 90 Years to less than 95 Years	40% of Basic Pension/Family Pension
From 95 Years to less than 100 Years	50% of Basic Pension/Family Pension
100 Years more	100% of Basic Pension/Family Pension

- (ii) In cases where exact date of birth of pensioner/ family pensioner if available in the PPO, the additional quantum pension/family pension on attaining the age of 80 years and above, would be payable at above mentioned rates from the first day of the month in which his/her date of birth falls.
- (iii) However in case the exact date of birth is not available either in the PPO or in the office records, but an indication regarding the age of pensioner/family pensioner is available, the additional quantum of pensioner/family pension shall be paid from the 1st January of the year following the age in which the pensioner/family pensioner has completed the age of 80 years and above, based on the Office records. No corrigendum PPO is required to be issued in such cases.
