Sub: Compliance of CIC Directions in connection with Provisions under RTI Act, 2005 - reg.

Sir/Madam,

The Central Information Commission (CIC) in its order dated 11.02.2019 passed in the matter of Shri Jai Singh (Applicant), Agra versus CPIO, ICMR to examine the contents of the RTI application and ensure placing of all such details on its website for perusal by all concerned within a period of 15 days from the date of receipt of this order. The CIC also instructed ICMR to convene periodic conferences/seminars to sensitize, familiarize and educate the concerned officials about the relevant provisions of the RTI Act, 2005 for effective discharge of its duties and responsibilities.

In view of the above, the Director General, ICMR has decided that the following may be followed scrupulously:-

- All ICMR Institutes/Centres of ICMR including ICMR Hqrs. should place the details of (i) the decisions, vacancies, etc. on the official website of the respective Institutes/Centres in total compliance of provisions contained in Section 4(1)(b) and 4(I)(c) of the Right to Information (RTI) Act, 2005.
- (ii) All Directors/Directors-in-Charge of ICMR Institutes/Centres should convene periodical conferences/seminars to sensitize, familiarize and educate the concerned officials about the relevant provisions of the RTI Act, 2005 for effective discharge of its duties and responsibilities.

All the provisions mentioned above and other related thereto may be downloaded from the concerned website of the RTI Act, 2005 for strict compliance.
