

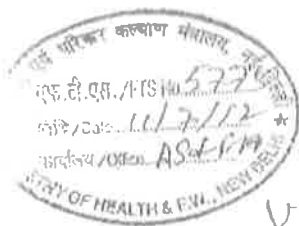
3. Grant of above 6<sup>th</sup> CPC Scales to the posts mentioned above would be subject to the following conditions:

- (a) Grant of above scales of pay to the eligible employees of BMHRC, Bhopal would be with effect from 1.9.2010.
- (b) The IFD of Ministry of Health & Family Welfare should ensure that the initial fixation of pay should be done with reference to Section-II, Part-A of the 1<sup>st</sup> Schedule of CCS (Revised Pay) Rules, 2008.
- (c) IFD /Financial Adviser of Ministry of Health & FW should ensure that the number of posts available in the BMHRC is verified, the existing employees get only the Grade Pay which they deserve based on their qualifications and experience and RRs are finalized at the earliest.
- (d) The Financial Adviser, Ministry of Health & Family Welfare should satisfy himself that the relativity in BMHRC, Bhopal vis-à-vis other organizations under the Ministry of Health & FW are maintained.
- (e) Since creation of additional post of Professor in lieu of Director General attracts ban on creation of posts issued by this Department vide our OM dated 31-05-2012. the same has not been agreed to.

BMHRC/FIN/304/2016/385 dated 25/08/2016 on the above subject and to convey approval of the Competent Authority for extending the benefits of the 7<sup>th</sup> CPC scales of pay to regular employees of BMHRC, Bhopal as certified vide ICMR order No.66/16/2012 NCD-II dated 19/07/2012 strictly in accordance with Central Civil Service (Revised Pay) Rules, 2016 notified vide Ministry of Finance, Department of Expenditure Notification No. GSR-721(E) dated 25.07.2016 and Department of Expenditure O.M. No.1-5/2016-IC dated 29.07.2016.

2. The matters regarding fixation of pay/ payment of arrears / other matters consequential to grant of 7<sup>th</sup> CPC scales, may be undertaken by BMHRC, Bhopal as per the above said guidelines of the D/o Expenditure and interpretation, if any, required in the matter will be provided by DHR. BMHRC, Bhopal must ensure correct fixation of pay.
3. An undertaking may be taken from each employee for acceptance of the benefits of 7<sup>th</sup> CPC and for the recovery of excess payment, if any, without notice.
4. All other formalities for implementation of recommendations of 7<sup>th</sup> CPC including permission to obtain option/ undertaking in the prescribed format will be done by BMHRC.
