Credit Facility to ICMR CGHS Beneficiaries under Emergency-Replacement of Existing procedure of Permission letter with identity Card and CGHS -regarding.

The undersigned is directed to inform that as per existing procedure the CGHS beneficiary of ICMR, when admitted in CGHS empanelled Hospital, are asked to produce permission letter from ICMR which causes difficulties to both serving and Pensioner. In order to mitigate the difficulties of employee, CGHS empanelled hospital of Delhi-NCR were requested to extend credit facility for treatment to ICMR employees/pensioner and their dependents holding valid CGHS card and identity card issued by the ICMR to serving employees and pensioner. Several CGHS empanelled hospital, as per list enclosed, have agreed to provide cashless medical treatment at CGHS rate to ICMR employees/pensioner and dependents at Delhi-NCR. The salient features of availing this facility are as follows:

ii) Pensioner of ICMR Hqrs., may get their Identity Card issued from resection office.

iii) Except in emergency, OPD treatment from empanelled hospital shall continue

to be availed only with prior permission from CGHS dispensary.

iv) In the event of expenditure exceeding beyond the delegated power of DG, ICMR i.e. Rs. 5.00 lakh per case, the employees/pensioner shall be liable to make necessary payment to hospital in advance and they can claim reimbursement as per CGHS rule/rate. If required, an undertaking in this regard may be furnished to hospital by the beneficiary at the time of admission in emergency.

v) The hospital shall intimate the details of patient admitted in emergency to the

concerned officer (as per list enclosed) within 24 hours of admission.

vi) The package rates, ceiling rates, specified duration of treatment nature and appropriateness of emergency, entitlement of the various wards, quality and standard of services, etc., shall be governed by the same terms and conditions of the agreement (MOA) between CGHS and empanelled hospitals.

vii) Hospital shall submit the bills alongwith self attested copy of valid CGHS card of beneficiary and identity card of the employees/pensioner of ICMR in accordance with the restrictions imposed by the Ministry of Health & Family Welfare vide
