The undersigned is directed to say that in pursuance of the decision taken by the Government on the Seventh Pay Commission's recommendations relating to advances, all the interest free advances stand discontinued as per attached annexure, with the exception that the interest free Advances for Medical Treatment. Travelling Allowance for family of deceased, Travelling Allowance on tour or transfer and Leave Travel Concession shall be retained.

- 2. In addition, the advance for training in Hindi through Correspondence Course, which is not mentioned in the Compendium of Rules on Advances to Government Servants, also stands abolished in pursuance of the decision of Government on 7th CPC recommendation.
- 3. These orders will take effect from the date of issue of this O.M. The cases where the advances have already been sanctioned need not be reopened.

in partial medification of this Department's C.M. of even number dated 07.07.2017 regarding implementation at the recommendations of the Seventh Central Pay Commission relating to grant of Transport Allowarice to Central Government employees, the President is pleased to decide that Central Government employees who are drawing pay of Rs.24200/- & above in Pay Level 1 & 2 of the Pay Matrix, i shall be eligible for grant of Transport Allowarice @ Rs.3600/- plus D.A. thereon at the cities contioned in the Annexure to the above cited 0.M. and @ Rs.1800/- plus D.A. thereon at all Other Places.

- 2 All other contents of the above cited C M, dated 07 07 2017 shall remain unchanged
- 3 These orders shall be effective from 1st July, 2017.
- These orders will apply to all civilian employees of the Central Government. The orders will also apply to the civilian employees paid from the Defence Service Estimates. In respect of the Armed Forces Personnel and Railway employees, separate orders will be issued by the Ministry of Defence and Ministry of Railways, respectively.
