

You are aware that Hon'ble Prime Minister of India, on 5th January, 2015, launched the National LED Programme to facilitate rapid adoption of LED-based home lighting and street lighting across the country. This programme along with Building Energy Efficiency Programme (BEEP) is being implemented by Energy Efficiency Services Limited (EESL), a joint venture company of four power sector Central PSUs. EESL works on Energy Services Company (ESCO) model wherein upfront investment is done by EESL and the investment is recouped on annuity basis with performance based guaranteed energy saving during the project period.

- 2. Government buildings are a major source of energy consumption and usage of LED based lightings and energy efficient equipment in government buildings will lead to economy in expenditure and savings in the long run through reduction in energy consumed.
- 3. In order to facilitate Ministries/Departments adopt the ESCO model, the Department of Expenditure *vide* its O.M. dated 4th August, 2017 (along with model agreement/contract) had made a request to convert the existing lightings/equipments into LED based lightings and energy efficient equipments on priority utilizing the services of CPWD/EESL. It was also requested to provide a status of the action taken by 15.08.2017.
- 4. A review of the action taken by the Ministries/Departments on 16.08.2017 reveals that not much, progress has been made.
