The Director General, Indian Council of Medical Research in consultation with Additional Secretary & Financial Advisor (AS &FA), Ministry of Health & Family Welfare and Department of Expenditure has approved the endorsement of Govt. of India, Ministry of O.M.No.1/1/2016-E.III, dated 13th January, 2017 relating to adoption of Seventh Central Pay Commission in Indian Council of Medical Research as per the pay matrix contained in Part-A of the Schedule to CCS(RP) Rule, 2016 after getting the approval vide Ministry of Finance, Department of Expenditure I.D.No.300323630/EIIIA, dated 03.04.2017.

- The pension of the ICMR pensioners is proposed to be revised/re-fixed with effect from 1st January, 2016 as per Pay Matrix corresponding to the grade pay drawn by the pensioner as on 31st December, 2015 and in accordance with the Concordance Tables issued vide Ministry of Personnel, P.G. and Pensions, Department of Pension & Pensioners' Welfare O.M. No.38/37/2016-P&PW(A), dated 6th July, 2016.
- 3.
