### SERVICE AGREEMENT

This Service Agreement is executed at -----21----- on day of 20<sup>th</sup> December, 2016 by and between :

2. Dr. Lal Path Labs Limited (LPL), a Company incorporated under the provisions of the Companies Act, 1956, having their registered office at Block E, Sector 18, Rohini, New Delhi-110085, and corporate office at 12<sup>th</sup> Floor, Tower B, SAS Tower, Sector 38, Gurgaon represented by Mr. Anil Chaudhary Designation>> hereinafter referred to as the "Lal Path Labs (LPL)", which expression, unless repugnant to the meaning and context, shall include their successors, heirs, legal representatives and assigns of the first part.

AND

3. Indian Council of Medical Research (ICMR) a Society under Society Act XXI 1860, V. Ramalingaswami Bhawan, Ansari Nagar, New Delhi-110029 and its four permanent Institutes viz.
- (i) The Director, National Institute of Pathology, Safdarjung Hospital Campus, New Delhi-110 029.
  - (ii) The Director, National Institute of Malaria Research, Dwarka, New Delhi-110 077.
  - (iii) The Director, National Institute of Medical Statistics, Ansari Nagar, New Delhi-110029.
  - (iv) The Director, Institute of Cytology & Preventive Oncology, Research-cum-Clinical Complex, Plot No.1-7, Sector-39, Near Degree College, Noida-201 301 (UP).
- (herein after referred to as Second Party) represented by Dr. Rakesh Kumar, Senior Deputy Director General (Admn.), ICMR, which expression, unless repugnant to the context or meaning thereof, shall mean and include its successors-in-interest and assigns of the other part.

WHEREAS, Lal Path Labs (PL) is one of the most renowned pathology testing laboratory and a premier institute in India capable of providing varied high end diagnostic tests and facilities and has established its state-of-art testing facilities at Sector-18, Block-E, Rohini, New Delhi-110 085, besides various other places in its proprietary trade name and style "Dr. Lal Path Labs Ltd., (hereinafter referred to as the "LPL").

WHEREAS Second Party has expressed its desire to avail the laboratory services & health-checkup services of LPL on some term and condition of agreement with the CGHS.

Now the parties are desirous of reducing the terms of agreement in writing as per the mutually agreed terms and conditions, mentioned below, and as per CGHS approved rates :

#### **Tenure**

Subject to the termination clause mentioned hereinafter, this understanding shall come into force with effect from the date of execution of this understanding and shall remain in force till 31<sup>st</sup> March, 2018.

#### **Scope of Service**

CGHS Card, Organization I-Card and Original Doctor Prescription from CGHS Dispensary or Govt. Hospital or Recognized Hospital under CGHS.

**The Terms & Conditions applicable for the above are as follows :-**

1. For any health check-ups, prior appointment/intimation is requested at [ekta.kumar@lalpathlabs.com](mailto:ekta.kumar@lalpathlabs.com)
2. Above packages are available Off Site (our company owned centers, Lab Pan India).
3. Service Tax on health check-ups as and when applicable shall be charged extra and payable by the client.
4. Second Party shall release the payment within 30 days from the date of invoice.
5. Soft Copy of reports will be sent by e-mail to the employee directly along with fitness certificate next day.
6. Hard copy of Reports will be sent on Weekly basis by Courier.

7. For home collection a charge of Rs.100/- per home collection shall be payable in addition to the amount of test as detailed in clause 1 herein above and the same will be payable by the individual.

#### **Billing Cycle**

Second Party shall pay all the charges towards the services rendered by the LPL under this Agreement within 30 days of date of invoice and all such payments shall be made by RTGS in favour of Dr. Lal pathlabs. Ltd. Payable at New Delhi by the concerned office as the case may be, as indicated in para 3 Second Party shall remit the amount of invoice in full without making any kind of deductions therefrom. Any delay in remittance of dues by the Second Party beyond agreed credit period of 30 days shall entail interest as per law.

#### **Relationship**

This arrangement is only on principal to principal basis and does not give rise to any principal and agent relationship or joint venture between the parties. Nothing stated in this arrangement will authorize or permit either party to represent or act as or plead any such relationship.

LPL shall not be responsible for any loss, damage, mutilation, delay of the samples or the report in transit, or in the event of its falling in unauthorized hands.

#### **Termination**

Either Party shall have the right to terminate this arrangement by giving 30 days prior notice in writing to the other without assigning any reason.

Upon termination or expiry of this Agreement as aforesaid, Second Party shall immediately pay to LPL the full amount of monies then due to LPL as per the provisions of this Agreement within 15 (fifteen) days of such termination.

#### **Governing Law**

The provision and implementation of this Agreement shall be governed by the laws of Republic of India.

#### Dispute Resolution

In the event of any dispute, difference of any kind, claims and questions whatsoever between the Parties hereto in connection with or arising out of this Agreement, including any dispute regarding its interpretation, breach, termination or validity, the Parties hereto shall promptly and in good faith negotiate with a view to its amicable resolution and settlement. In case, no amicable resolution or settlement is reached within a period of 30 (thirty) days from the date on which dispute or difference arose, then such dispute or difference shall be referred to a sole arbitrator appointed by LP L.


