ORDER

Whereas, a request for grant of exemption from the operation of provisions Section 11 of the FCRA, 2010 to accept foreign contribution in cash or kind to undertake research activities without obtaining the approval of the Central Government has been received in respect of Indian Council of Medical Research, New Delhi.

2. AND Whereas, the Indian Council of Medical Research, is ~~an~~ an autonomous body registered under the Registration of Societies Act of 1860 and run under M/o Health and Family Welfare, D/o Health Research.

3. Now, therefore, in exercise of powers conferred under Section 50 of the Foreign Contribution (Regulation) Act, 2010, Central Government hereby exempts the Indian Council of Medical Research from the operation of provisions of Section 11 of the FCRA, 2010 in terms of the provisions contained in Section 50 thereof to accept foreign contribution in cash or kind subject to the conditions as under: -

- i) All foreign contributions would be received in an exclusive designated bank account only.
- ii) A separate set of accounts and records in respect of the foreign contribution received and utilized would be maintained.
- iii) Due diligence will be exercised to ascertain the bonafides of the contributors prior to receiving any contributions in the fund.
- iv) The accounts will be compulsorily audited by CAG.

5. This issues with the approval of Competent Authority.
