Dear Sir,

Ministry of Human Resource Development administers a Central Sector Plan Scheme called Interest Subsidy on Educational Loans for higher education. Under this Scheme interest subsidy is given on the educational loans under the IBA Educational Loan Model Scheme taken by the students from scheduled banks and sponsored co-operative and regional rural banks for undergoing professional/technical courses, especially in the field of higher education, during the course period plus 1 year or 6 months after employment, which is earlier, to the economically weaker sections having an income from all sources annually up to Rs. 4.5 lakh. In order to enable the students to avail of the benefits and also enable the banks to give the subsidy for the professional/technical courses in the realm of higher education it would be worth a while if your Ministry/Department and other institutions under your Ministry display and update the professional/technical courses duly approved and certified in the respective websites and also keep all the regulatory agencies as well as MHRD posted from time to time. In this connection we did write to various Ministries in the past on 14.2.2012 vide letter of even no. with reminders but the response has been partial and also no updated status on the information having been placed on the websites has been sent. Some of the Ministries which have partially responded are M/o Tourism, M/o Commerce, M/o Petroleum and Natural Gas, M/o Civil Aviation, M/o Shipping and some institutions like Indian Institute of Packaging, MCI and Indian Maritime University. I would request you to kindly ensure that all the professional courses concerning your Ministry/Department/Institutions are placed and updated in the websites and the regulatory authorities like UGC, AICTE, MCI, NCI, PCI, ICAR etc., as well as MHRD informed from time to time.

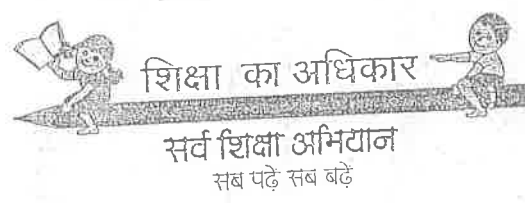
