

- The notable initiatives taken by the Ministry for the welfare of workers are as 2. follows:
- (i). The minimum wages of non-agricultural workers has been increased by 42% i.e. from Rs. 246/- to Rs. 350/- per day in the C area category; from Rs. 301/- to Rs. 431/- per day for B area category; and from Rs. 368/- to Rs. 523/- per day for A area category.
- Minimum wages enhanced in all sectors in Central Sphere simultaneously for the (ii).
- Central Government will pay Bonus on revised norms for the years 2014-15 and (iii). 2015-16 to all eligible non-Gazetted officials.
- Minimum pension under EPS of EPFO has been enhanced to Rs. 1000/- per (iv). month.
- Paid maternity leave is being enhanced from 12 weeks to 26 weeks. (v).
- A Committee is being constituted to examine the issues related to Social Security (vi). for the unorganized sector (eg. Anganwadi Workers, Mid-day Meal Workers, ASHA Volunteers etc).
- Pradhan Mantri Rozgar Protsahan Yojana has been launched. In this scheme, (vii). Government will contribute the Employer's 8.33% EPS share for the next 3 years in case of new employment. In Textile sector, Government will pay additional 3.67% EPF share. This will help in enhancing employment opportunities.

3. It is observed that the above pro-worker initiatives have not properly percolated to the working class. I would therefore request you to intervene and take appropriate measures to disseminate the above initiatives of the Government to the workers through your PSUs/ Autonomous Bodies etc. using their in-house communications mechanism. This needs to be done urgently so that workers become aware of pro-active initiatives taken by the Government before they take a view on their involvement in the strike on 2nd September, 2016.
