MINUTES OF THE MEETINGS HELD ON 4th, 5th and 8th of APRIL, 2016 IN ROOM NO. 190, NORTH BLOCK, NEW DELHI UNDER THE CHAIRMANSHIP OF SECRETARY (P) ON 'DECLARATION OF ASSETS AND LIABILITIES BY PUBLIC SERVANTS UNDER SECTION 44 OF THE LOKPAL AND LOKAYUKTA ACT, 2013' - FILING OF RETURNS BY PUBLIC SERVANTS ON OR BEFORE 15.04.2016*

Secretary (P) took meetings on 04-04-2016, 05-04-2016 and 08-04-2016 to discuss and interact with Secretaries / senior officers of key Ministries / Departments on the subject 'Declaration of Assets and Liabilities by Public Servants under Section 44 of the Lokpal and Lokayuktas Act, 2013' by public servants referred to in the provisions of section 14(1)(g) and (h) of the Act . The list of officers who attended this meeting is at Annexure, I-A, I-B and I-C respectively.

- 2. At the outset, Secretary (P) apprised the participants from the Ministries / Departments regarding the requirement of declaration of assets and liabilities by all categories of public servants, defined under section 2(1)(o) read with section 14 (1) (a) to (h) of Lokpal and Lokayukta Act, 2013, under the provisions of the section 44 of the said Act. Secretary (P) further highlighted the fact that these returns as on 01-08-2014 and 31-03-2015 are required to be filled up by all public servants, by 15th April, 2016*, mandatorily, as per provisions of the said Act.
- 3. Attention of officers present in the meeting was drawn to the fact that the 'competent authority' for the category of public servant under section 14 (1) (g) of the Act has to be notified by the Central Government as required under section 2(1) (c) (vii) of the said Act. It was further informed that the 'competent authority' of the concerned Ministry / Department has to be an officer with sufficient seniority, for example, Joint Secretary to Govt. of India or equivalent level, in respect of such trust/ society/ association of persons. A 'template' regarding notification of competent authority to be issued by the respective Ministry / Department for category of public servants referred to in section 14(1)(g) of the said Act was discussed with all the participants present in the meeting with the advice to get the same approved from the concerned Minister-in-charge. It was also decided that the Ministries / Departments would notify the 'competent authority' in respect of such trust/ society / association of persons under them as per the Act, as soon as possible. A proforma available at Annexure-II was circulated to the participating Ministries/ Departments to collect information about

such societies/ trusts / associations of persons financed by them and the concerned employees.

- 4. Further, it was reiterated that the statements of returns on assets and ilabilities of such public servants are not to be published on the web-sites until 31.08.2016.
- 5. During the discussions, it was brought to the notice of all concerned that the annual income of such societies/ trusts/ association of persons has to be clearly indicated so that such bodies whose income exceeds the specified limit would fall under the Lokpal and Lokayukta Act, 2013 and director, manager as per provisions of sec 14(1)(g) off such bodies would be required to comply with the provisions of filing declaration of assets and liabilities, mandatorily by 15th April, 2016*.
- 6. In the meeting, a query was raised whether subsidies provided and funding of specific projects by a particular Ministry/ Department would be treated as 'income' for the purpose of calculating 'annual income' of such societies/ trusts/ association of persons under the Act. It was informed that clarification would be issued by DoPT on this issue separately. There was further discussion on the issue of cut-off 'income' of such societies/ trusts /association of persons wherein suggestions regarding fixing the limit in excess of Rs. 10 lakh in a year in respect of societies/ trusts/ association of persons, covered under provisions of section 14(1)(h), receiving donations from foreign sources under Foreign Contribution (Regulation) Act, 2010, and limit in excess of Rs. one crore in a year in respect of societies/ trusts/ association of persons, covered under provisions of section 14(1)(g), which are fully or partly financed by the Central Government, were given. It was informed that the decision on the aforesaid limits to be fixed would also be intimated separately.
- Meetings ended with a vote of thanks to the chair.

G.S.R. 414(E).—In exercise of the powers conferred by sub-section (1) read with clause (k) and clause (m) of sub-section (2) of section 59 read with section 44 of the Lokpal and Lokayuktas Act, 2013 (1 of 2014), the Central Government hereby makes the following rules further to amend the Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Rules, 2014, namely:—

- 1. (1) These rules may be called the Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Amendment Rules, 2016.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In the Public Servants (Furnishing of Information and Annual Return of Assets and Liabilities and the Limits for Exemption of Assets in Filing Returns) Rules, 2014, in rule 3, in sub-rule (2),—
 - (a) in the first proviso, for the words and figures "on or before the 15th day of April, 2016", the words and figures "on or before the 31st day of July, 2016" shall be substituted;
 - (b) in the second proviso, for the words and figures "on or before the 15th day of April, 2016", the words and figures "on or before the 31st day of July, 2016" shall be substituted.
