Call for Expressions of Interest for inclusion as member in Scientific Committee and Scientific Panels of the Food Authority already has been published on 9th April, 2016 in national and regional news papers and also on FSSAI website.

- 3. The Authority is looking for suitable individuals as Chairman and members of the selection of members of the Committee/Scientific Panels. The tenure of the Assessment Committee will be 3 years. Detail of the eligibility and procedure for selection of Assessment Committee is available on FSAAI website at http://fssai.gov.in/Portals/0/Pdf/Proc SC SP 08 03 16.pdf. Applicants who have applied for the member of the Scientific Committee/ Panels are not eligible to serve in the Assessment Committee.
- Members selected on the Assessment Committee would need to undertake visits to Delhi where the meetings of the Assessment Committee will be held. A commitment to devote time and resources for the deliberations in the meetings is expected. Membership would be given in their individual capacities and are required to avoid any conflicts of interest. The Food Authority shall meet the travel and lodging expenses of members, in addition to a token sitting 3.56 fee as applicable.
