GUJAR MAL MODI INNOVATIVE SCIENCE AND TECHNOLOG AWARD

Gujar Mal Modi Innovative Science & Technology Award is among the highest cash awards in the country in the field of Science and Technology. The award was instituted in 1988 in the memory of the great industrialist of India, late Rai Bahadur Gujar Mal Modi of Modingar. It will be given each year to a person who has demonstrated the qualities of excellence and innovation through outstanding research and in providing leadership in the development and promotion of Science and Technology in India. The Awards already made to outstanding Indian scientists and technologists are indicative of the class of this Award.

For this award the governing body of the Gujar Mal Modi Science Foundation will invite nominations each year from the following.

1. Presidents of approved Science and Engineering Institutions of All India character.
2. Vice Chancellors of Scientific/Engineering Universities.
3. Directors of Institutes deemed to be of University status (Science & Engineering Faculties)
4. Secretaries of the Departments of Science & Technology both of the Central Government and State Governments
5. Scientific Advisor to the Prime Minister.
6. Member Incharge of Science and Technology in Planning Commission.
7. Scientific Advisor to the Defence Minister
8. Director General C.S.I.R.
9. Directors of I.I.T.S.
10. Directors of C.S.I.R. Laboratories
11. Chairman of Atomic Energy, Space, Oil and Natural Gas Commissions.

The nominations may be sent alongwith three copies of detailed statement of work and achievement of each nominee with atleast one set of re-prints of papers published/accepted during the proceeding 5 years. Nominations signed by the sponsors should be sent in a sealed cover. to the Secretary, Gujar Mal Modi Science Foundation, Mezzanine Floor, Modi Tower, 98, Nehru Place, New Delhi-110019 so as to reach him not later than 25th May each year for that year's award.

Awardee will be informed of the award before 31st July. He should be prepared to come to a predetermined place to receive his award.
