Subject: Revision of Emoluments and guidelines on Service Conditions for

Research Personnel Employed in R & D Programme of the Central

Government/Department/Agencies.

Sir/Madam,

In continuation of Council's letter of even number dated 17.2.2015 on the subject mentioned above, I am directed to inform you that the Director-General, ICMR has accorded the approval to the applicability of revised slab of stipend to three different categories of Research Associates (RAs) with reference to duration of engagement as under:-

(i) Research Associate-I Rs.36,000/- p.m. for first two years.

(ii) Research Associate-II Rs.38,000/- p.m. for third year.

(iii) Research Associate-III Rs.40,000/- p.m. for fourth year.

If a fellow has drawn first slab of Rs.36,000/- p.m. in some earlier project and thereafter joins another project, he/she will be placed in the 2nd slab. Likewise, if a fellow has already availed first & second slab in some projects, then he/she will be granted 3rd slab of Rs.40,000 p.m. If he/she joins a new project/fellowship, previous incomplete duration of a year will not be taken into account for deciding the placement in higher slabs.

- 2. <u>Eligibility Condition</u>: In ICMR, research fellows come from Life Science/Biomedical/Social Science background, and, therefore, the eligibility criteria for Research Associateship applicable in DST i.e. postgraduate qualification with 3 years of research experience plus-2 research publications will not be applicable. The minimum educational qualification for RA will be Ph.D in Life Science/Social Science/Biomedical Sciences or M.D./M.S./M.V.Sc. in Medical/Dental/Veterinary discipline.
- 3. All other terms & conditions and rate of stipend for JRFs and SRFs will remain unchanged as stipend in Council's letter dated 17.2.2015.
