The undersigned is directed to refer to Department of Personnel and Training's OM No.13018/6/2013-Estt(L) dated 11<sup>th</sup> September 2015 on the subject mentioned above and to say that as per the technical comments provided by the Maternal Health Division of this Department, "Surrogate Mother bears the foetus for nine months during pregnancy and irrespective of whether she is a Government Servant or not, it is proposed that she should receive maternity leave of 180 days (6 months) for post-partum care, before she resumes work". The Child Health (CH) division of this Department also concurred with this view and have stated that this is important to promote exclusive breast feeding of children for six months.

Further, a copy of DoPT's OM is also being forwarded to Indian Council of Medical Research (ICMR) for their comments on the matter.

The proposal pertains to allowing grant of Maternity Leave & Child Care Leave to surrogate/commissioning mothers.

- 2. This Department has been receiving several requests from female Government servants for grant of maternity/child care leave, where they beget children through surrogacy.
- 3. If it is decided to allow leave to a female employee, who gets a child through Assisted Reproductive Technologies, through another woman who acts as the surrogate, the quantum of such leave granted to either/both the women, as well as any other terms & conditions attached to the grant of such leave may need to be kept in mind. It is possible that the time required for a surrogate mother for recovery may differ from the time required by the commissioning mother for the care and upbringing of the child.
- The following three scenarios could be envisaged:-
- (i) Both surrogate mother and commissioning mother are Government Servants:- It is felt that only the commissioning mother will be eligible for Maternity Leave, as the surrogate mother will make over the child immediately after its birth to the commissioning mother who will be responsible for its care and up-bringing. However, the surrogate mother may require some leave for recovery, post child birth.
- (ii) Commissioning mother is not a Government Servant but surrogate mother is a Government Servant:- Surrogate mother would not be eligible for Maternity Leave as per the extant definition. However, she may become entitled to leave post child birth.

- (iii) Commissioning mother is a Government Servant but surrogate mother is not a Government Servant: In this situation the commissioning mother may be entitled to Maternity Leave starting from child birth.
- 5. The Ministry of Health & Family Welfare is requested to examine the proposals and forward their comments especially on the quantum of leave that should be allowed in each case.
