Dear Secretary,

As you are aware, plastic is a non-bio-degradable substance and its improper disposal causes many problems for us.

2. We in the Government offices can also ban the use of plastic folders to avoid future pollution.
3. I would request you to kindly encourage discontinuation of the use of plastic folders in your Ministry and start using eco-friendly hand-made paper folders. Cost of hand-made paper may be a little more, but it will be cheaper if environmental benefits are taken into account.
