 - c) He/She should bring the impact factor of his/her publications during the assessment period and also the citation index of top 5 best cited papers.
 - d) He/She has to present his work within 7-8 minutes through computer being provided during the interview. He/She should prepare 5-6 slides and bring ten copies of each slide in hard copy and also soft copy in pen drive for presentation.
