



NOTIFICATION

G.S.R. .... In pursuance of provisions of rule 45 of the Fundamental Rules, the President hereby makes the following rules further to amend the Allotment of Government Residences (General Pool in Delhi) Rules 1963, namely :-

1. **Short Title & Commencement:**

- (1) These rules may be called the Allotment of Government Residences (General Pool in Delhi) Amendment Rules 2013.
- (2) They shall come into force from the date of their publication in the official Gazette.

2. **In the Allotment of Government Residences (General Pool in Delhi), Rules, 1963**

- (a) In Supplementary Rule 317-B-11, in the table below sub-rule (2), against the item (ii) relating to retirement or terminal leave, for the figure and words "**2 months on normal licence fee and another 2 months on double the normal licence fee**" occurring under the column relating to permissible period for retention of the residence, the figure and words "**2 months on normal licence fee**" shall be substituted.
- (b) In Supplementary Rule 317-B-22, the existing provision in para 3 i.e.  
"Provided further that in the event of retirement or terminal leave, the allottee shall be eligible to retain the Government accommodation for a further period of two months on payment of four times of the normal licence fee and subsequent two months on payment of six times of the normal licence fee for special reasons involving medical/educational grounds, subject to appropriate certification by the authorities concerned"

2. The amendment notified vide the aforesaid Gazette shall be applicable to all the allottees of General Pool Residential Accommodation retiring on or after 23.4.2013.

3. It is clarified that the aforesaid amendment shall not be applicable to the allottees who have retired prior to 23.4.2013 and they will be eligible for retention of accommodation as per the rules in force prior to the aforesaid amendment.



सा.का.नि. 262(अ).—मूल नियमावली के नियम 45 के उपबंधों के अनुसरण में राष्ट्रपति सरकारी आवास (दिल्ली में सामान्य पूल) आबंटन नियमावली, 1963 में और संशोधन करने के लिए एतद्वारा निम्नलिखित नियम बनाते हैं, अर्थात् :—

**1. संक्षिप्त नाम और प्रारंभ :**

- (1) इन नियमों को सरकारी आवास (दिल्ली में सामान्य पूल) आबंटन संशोधन नियमावली, 2013 कहा जाएगा।
- (2) ये नियम सरकारी राजपत्र में प्रकाशन की तारीख से लागू होंगे।

**2. सरकारी आवास (दिल्ली में सामान्य पूल) आबंटन नियमावली, 1963 में**

- (क) अनुपूरक नियम 317-ख-11 में, उप-नियम (2) के नीचे सारणी में, सेवानिवृत्त अथवा सेवांत छुट्टी से संबंधित मद(ii)के सामने आवास के प्रतिधारण के लिए अनुमेय अवधि से संबंधित कॉलम में उल्लिखित "सामान्य लाइसेंस शुल्क पर 2 महीने तथा सामान्य लाइसेंस शुल्क के दुगने पर आगे और 2 महीने" अंकों और शब्दों को "सामान्य लाइसेंस शुल्क पर 2 महीने" अंकों और शब्दों द्वारा प्रतिस्थापित किया जाएगा।

- (ख) अनुपूरक नियम 317-ख-22 में, पैरा 3 में मौजूदा प्रावधान अर्थात्—

"परन्तु यह और कि सेवानिवृत्त होने अथवा सेवान्त छुट्टी पर जाने की स्थिति में आबंटनी सामान्य लाइसेंस शुल्क के चार गुना के भुगतान पर आगे और दो महीने की अवधि के लिए और उसके बाद के दो महीनों के लिए संबंधित प्राधिकारियों द्वारा समुचित प्रमाणन के अधधीन चिकित्सा/शैक्षिक विशेष कारणों से सामान्य लाइसेंस शुल्क के छः गुना के भुगतान पर सरकारी आवास को प्रतिधारित करने के लिए पात्र होगा।"
