#### **Terms and Conditions**

- 1. The agency should hold valid license, registration and permissions that are required under the applicable local/international laws for logistic services.
- 2. The contract will be entered for a period of One year from the date of award of contract.
- 3. The agency should have at least 5 years' experience in the field of transporting heavy duty lab equipment and biological samples.
- 4. A penalty can be imposed on the agency by ICMR-NIRRCH @  $\frac{1}{2}$  % (half percent) of the total value of the invoice value to a maximum of 5% (five percent).
- 5. The agency must have the facility to store the shipment at appropriate temperature once cleared from the Customs in case the shipment is not delivered due to any unforeseen reasons.
- 6. The agency should not have been black listed by any Government agency or private organization. A certification to this extent should be enclosed. Any such information received later on can lead to termination of the contract without assigning any reason and a penalty to the extent of damage caused if any during the contract period will be levied.
- 7. The agency should provide all the supporting documents mentioned above failing which their tender/bid will not be considered for short listing.
- 8. The service provider should be specialized in transport of Biological samples and reagents
- 9. The service provider should have validated / approved packing materials
- 10. The service provider should have integrity, identity and security system for each consignment
- 11. The service provider should have facility to pick up from ICMR NIRRCH or any other location in India as per the requirement of the end user
- 12. Consignment may contain biological samples reagents and consumables for medical research
- 13. Biological samples, reagents and consumables are to be shipped in dry ice / Liquid Nitrogen as per the requirement of the end user Scientist / Department.
- 14. Separate charges are to be submitted for Liquid Nitrogen and Dry ice
- 15. Charges quoted should include standard packaging box charges.
- 16. Service Provider has to determine the best date for shipping with consideration to holidays and adverse weather conditions. Shipments must be scheduled to arrive at the Institute between 10:00 AM and 4:00PM IST. Notify the Institute of the shipment with the expected date and time of arrival.

#### Scope of Work:

- 1. Distribution of consumables, reagents and kits from ICMR NIRRCH to the participating clinical research units Quarterly. ICMR NIRRCH will provide the materials to be shipped. The Shipper should arrange for internal and external boxes, gel packs, packing materials. The shipping agency will only need to transport through drive way and or air transfer to the consignee.
- 2. The dimension of the consumables, reagents and kits will be informed to the shipping agency in advance based on the requirements from the clinical research units.
- 3. It is very important that the shipment of samples, consumables, reagents and kits be done at the appropriate time and temperature.
- 4. Only authorized and trained persons from the courier agency should handle clinical samples and related documents.
- 5. Door to door premium transportation services (excluding import duty and tax) should be provided.

- 6. All shipments should be on the first available flight and monitored until delivery
- 7. Trained personnel should be responsible for packing as per UN/IATA guidelines.
- 8. The Agency should undertake packing and forwarding of the shipment as per guidelines.
- 9. The samples/kits/reagent will be required to be ship with the dry ICE, Liquid Nitrogen, Cool packs or at ambient temperature according to the nature of items shipped.
- 10. Necessary arrangements should be made for material required for maintaining cold chain at the time of pick-up of shipment.
- 11. The shipment should be forwarded on the same day of pickup and should reach the destination on the same day or next day based on the clinical research unit is located.
- 12. The agency should be able to provide ICMR-NIRRCH access for online Real-Time tracking facility of the location of the various parcels during the process of shipment.
- 13. No charges will be paid to the agency if the required temperature of the shipment is not maintained and/or monitored through data logger if used or if the shipment reaches the destination beyond 2-3 days of dispatch, and/or if the box is found to be or damaged upon receipt at the destination.
- 14. Special care should be taken while collecting and delivering parcels containing liquid bottles, ampoules and vials.

- 2. Necessary permissions / licenses as required for the specified services / works to be possessed by the bidder, the lack which is a criterion for disqualification technically.
- 3. The tender not submitted as per the above prescribed manner will be treated as invalid. All outstation tenders should be sent to so as to reach before the prescribed time limit. Late/delayed Tenders shall not be considered under any circumstances.
- 4. Tender should be accompanied by an undertaking wherein it may be stated that 'If they withdraw or modify their bid/s during period of validity etc. they will be suspended as per the directions of competent authority of the Institute'. The offer without Undertaking & EMD would be summarily rejected.
