Buyer Added text based ATC clauses

- Bidder should be recognized from the Department of Tourism, Govt. of India/ State Govt./Any other Public Institution/ Body.
- The bidder should own (minimum One) or on lease sufficient vehicles of model not older than an year March 2020 vehicles registered as commercial vehicles in their names or firm"s name for use as commercial vehicles. The proof of ownership or lease holding should be produced along with the qualifying bid documents.
- If vehicle is not commercially registered, approved supplier, shall get the vehicle commercially registered within one month from the award of the work and submit the proof to O/o Director, ICMR – NIRRCH, Parel, Mumbai -12.
- The bidder shall also submit full details of the vehicles that can be assigned in their favor and shall give a clear declaration that the firm will be able to supply commercial vehicles of model not older than March 2020.

v. The bidder shall have experience of minimum period of 2 years for similar supplying not less than Two commercial vehicles/cars to any Central/State Govt. organization or any large Public Sector Undertaking.

vi. Insurance : The Insurance cover protecting the agency against all claims applicable under the Workman's Compensation Act 1948 shall be taken by the Contractor. The Contractor shall arrange necessary insurance cover for any claim arising out of mishap, if any, that may take place. In the event of any liability/claim falling on O/o Director, ICMR - NIRRCH the same shall be reimbursed /indemnified by the Contractor

vii. Execution Time Limit: The time period as stipulated in the contract or letter of intent shall be deemed to be essence of the contract.

viii. **PAYMENT TERMS**

Monthly bills shall be submitted in duplicate to the authority specified in contract along with duty slips duly signed by the user.

ix. The liability under relevant sections of Motor Vehicle Act 1968 and IPC causing death or permanent liability developed in the vehicle supplied by the contractor, the hiring authority has no responsibility of whatsoever and will not entertain any claim in this regard under the provision of the law.

x. The engagement and employment of drivers and payment of wages to them as per existing provisions of various labour laws and regulations is the sole responsibility of the contractor and any breach of such laws or regulations shall be deemed to be breach of this contract.

xi. No subcontracting is permissible

xii. The contractor shall assign the job of driving of hired vehicles only to qualified experienced licensed drivers and also assume full responsibility for the safety and security of the officers / officials as well as essential store items while running the vehicle by ensuring safe driving. ICMR - NIRRCH shall have no direct or indirect liability arising out of such negligent, rash and impetuous driving which is an offence under section 29 of IPC and any loss caused to ICMR - NIRRCH have to be suitably compensated by contractor. Drivers should have minimum 3 years of experience of driving. They should have Vehicle Transport License for driving passenger vehicles.

xiii. The contractor shall when called upon to do so, place at the disposal of ICMR - NIRRCH such number of vehicles as may be required although the number of vehicles so demanded may be more than the number of vehicles he is required to supply for the purpose of execution of the contract at same rate and terms and conditions. The number of such vehicles to be supplied extra will not be more than 25% of original schedule or requirement.

xiv. In no case a vehicle which is not registered for the commercial purpose shall be supplied to ICMR - NIRRCH and taxes etc. due to on such vehicles shall be liability of the contractor.

xv. The contractor shall send the vehicle for periodical servicing at the cost of the contractor, ICMR - NIRRCH will not pay any mileage run for such servicing nor any deduction be made for the duration involved in such servicing. The cost of lubricants, repairs, maintenance, taxes insurance, etc. will be to the contractor's liability.

xvi. ICMR - NIRRCH reserves right to counter offer price against price quoted by the bidder.

xvii. Regular checking of meter by the designated transport authority may be done by the contractor, and requisite certificate may be shown to ICMR - NIRRCH as and when demanded.

xviii. **Quantity** : Estimated number of vehicles to be hired on monthly basis is 2, however it should be clearly noted that ICMR - NIRRCH shall place the order only as per the actual requirement from time to time. Vehicles may be hired on daily basis also as per requirement.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and

conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process.
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
