TERMS & CONDITIONS:

- 1. Tenders (Two Bid Technical and Financial in two separate envelopes, placed in one large envelope) should reach ICMR-National Institute for Research in Reproductive and Child Health, Jehangir Merwanji Street, Parel, Mumbai 400012, Maharashtra before the prescribed date and time.
- 2. The tender not submitted as per the above prescribed manner will be treated as invalid. The last date for receipt of tenders in ICMR-NIRRCH is 16th May, 2024 up to 17.00 hrs. The offers received would be opened on 17th May, 2024 at 11.00 hrs. In case it is not possible to submit the tender in hard copy, email offers could be submitted to our email (<u>stores@nirrh.res.in</u>), within the prescribed time limit, wherein the financial bids may be submitted in a password protected file. The password would be requested in case the offer is technically qualified. The agencies who participate in the said tender would be intimated by email regarding the award of tender.
- 3. The bidders can participate for entire or partial requirement viz. tender can be submitted for one, two, three or all four laboratory investigations. If quoting for only PCOS Blood Investigations, the quote should be submitted for all the tests required under said investigation.

4. Important Terms and Conditions:

- For all Tests (including PCOS Blood Investigations):
 - Required NABL accredited labs.
 - The test rates once agreed upon should not be revised during the entire period of the contract.
 - All the routine test need to be reported within 24 hrs from the time of collecting the samples.
 - The laboratory/agency should provide round the clock service at no extra cost.
 - During the health camps conducted by ICMR-NIRRCH, Mumbai, the bidder need to provide sufficient manpower as desired by ICMR-NIRRCH.
 - Any legal liability arising out of such laboratory investigations services shall be the sole responsibility of the laboratory/agency.
 - The scope of service to be covered includes all age groups and genders with resuscitation facilities at the place of investigation.
- With respect to PCOS Blood Investigations:
 - All the required materials will be carried by lab only.
 - Phlebotomy will be provided by laboratory.
 - Blood investigation reports should be provided in duplicate.
 - Facility of online / web reporting should be provided.

- Sample to be collected by ICMR-National Institute for Research in Reproductive and Child Health (ICMR-NIRRCH), Parel, Mumbai. The said cost should be borne by the laboratory.
- Bidder shall provide sample pickup facility.
- The sample shall be collected from the labs depending upon our requirements.
- The bidder shall make his own arrangement at his cost to get the samples collected from ICMR-NIRRCH under ideal conditions specific for the samples. In case of any emergency investigations the sample must be collected as and when informed telephonically round the clock. The laboratory shall have to provide containers, sample collection device (vacutainers), related material for collecting all samples outsourced.
- 5. The Director, ICMR-NIRRCH, reserves the right to call for break-up of the quotation if it is found necessary.
- 6. The offers should be kept valid for acceptance for a period up to **16th August**, **2024**.
- 7. The Institute will enter into a **Rate Contract** with the agency whose offer is selected, which will be valid for **One Year**, extendable further, if mutually agreed upon.
- 8. Rates to be quoted separately for each test category-wise as per enquiry (even if repeated).
- 9. The Director, ICMR-National Institute for Research in Reproductive and Child Health (NIRRCH) does not bind itself to accept only the lowest offer. It reserves the right to accept or to reject any offer without assigning any reason.
- 10. The rate of taxes / discount must be clearly indicated wherever chargeable G.S.T. number must be indicated. It will be deemed that No Taxes are payable by us, if the same are not mentioned.
- 11. Payment will be made by Online Bank Transfer after receipt of the reports in satisfactory condition in full and bills (both in soft and hard copy, preferably on monthly basis), duly approved by competent authority of ICMR-NIRRCH.
- 12. Offers made on conditions like "Subject to" or "Subject to availability of stores" or "Taxes as applicable" or such other vague conditions are likely to be ignored.
