Director/Director in-charge of ICMR Institutes/Centres and Sr. Dy. Director General (Admn.) and Asstt. Director General (A) at ICMR Hqrs may exercise financial powers, within delegated limit, to incur expenditure on Contingent and Miscellaneous items, as given in Schedule -V and VI of DFPRs, without consultation with Sr. Financial Advisor of the Council, subject to availability of budget and observance of procedure contained in GFR.
