## Terms and conditions:-

- 1. These positions are meant for temporary projects, for appointment purely on temporary contract basis.
- 2. Age relaxation will be admissible in respect of SC/ST/OBC candidates, retrenched Government Employees, Departmental Candidates (including projects) and Ex-servicemen etc. in accordance with the instructions issued by the Central Government/DoPT/ICMR from time to time. Age concession to the extent of service rendered in other research projects will also be admissible for experienced and skilled persons. SC/ST/OBC will be given age relaxation in respect of the posts reserved for them only and not for UR posts.
- 3. Cut-off date for age limit will be as on the last date for submission of applications.
- 4. Age relaxation will be as per the guidelines of ICMR

- 5. OBC category candidates must produce their latest Caste Validity Certificate. They must possess a latest non-creamy layer certificate, issued within three years. PWD candidates shall produce latest disability certificate issued by a Medical board of Government hospital with not less than 40% disability.
- **6.** Engagement of successful candidates on the project shall also be decided by the appointing authority at its discretion.
- 7. Qualification & experience should be in relevant discipline/field/trade and from an accredited/ reputed Institution. Experience should have been gained after acquiring the minimum essential qualification.
