Late / Delayed / Incomplete applications shall not be entertained and rejected straight away, without any reasons, communication and correspondence.

Candidature of selected candidates shall be subject to verification of all original documents by ICMR and fulfilment of required eligibility criteria, in all respects of qualification, age and experience, etc.

General Conditions for engaging Consultants: -

1. Apart from retired employees from Central and State Govt/Autonomous Organizations/PSUs, etc, other professionals with requisite qualifications and experience would also be eligible for engagement as Consultants. In case of retired govt. servants, the engagement as full time Consultant shall not be considered as a case of re-employment, in any manner.
2. Consultants would be engaged for a fixed period, on a consolidated monthly remuneration, to provide high quality services, attending to specific job, within prescribed time frame. Such remuneration shall remain fixed during the entire period of contract.
3. As the engagement of Consultants would be on full-time contract basis, they would not be permitted to take up any other assignment, either part time or full time, during the period of such engagement.
4. The contract of Consultant is of a temporary nature and can be terminated anytime, without any prior notice and without providing any reason for it. However, in normal course, termination of contract may be done by giving not less than one month's notice on either side at any time, without assigning any reason.

TERMS AND CONDITIONS:

1. These positions are meant for temporary projects, for appointment purely on temporary contract basis and are co-terminus with the project.
2. Engagement of the above advertised Project Human Resource Positions will depend upon availability of funds, functional requirements and approval of the Competent Authority. Therefore, we are not committed to fill up all the advertised Project Human Resource Positions and the process is liable to be withdrawn/cancelled/modified at any time.
3. The rates of emoluments/stipend shown in this advertisement are project specific and may vary according to sanction of the funding agency of the Project.
4. Cut-off date for age limit will be as on the date of last date for submission of applications (date of interview in case of walk-in interview).
5. Age relaxation will be admissible in respect of SC/ST/OBC candidates, retrenched Government Employees, Departmental Candidates (including projects) and Ex-servicemen etc. in accordance with the instructions issued by the Central Government/DoPT/ICMR from time to time. Age concession to the extent of service rendered in other research projects will also be admissible for experienced and skilled persons. SC/ST/OBC will be given age relaxation in respect of the posts reserved for them only and not for UR posts.
6. OBC category candidates must produce their latest Caste Validity Certificate. They must possess a latest non-creamy layer certificate, issued within three years. PWD candidates shall produce latest disability certificate issued by a Medical board of Government hospital with not less than 40% disability.
7. Age relaxation will be as per the guidelines of the ICMR.
8. Qualification & experience should be in relevant discipline / field and from an Institution of repute. Experience should have been gained after acquiring the minimum essential qualification.
9. Mere fulfilling the essential qualification does not guarantee the selection.
10. Persons already in regular time scale service under any Government Department / Organizations are not eligible to apply.
11. No TA/DA will be paid to attend interview/personal discussion and candidates have to arrange transport/accommodation themselves.

12. Competent authority of ICMR-Hqrs, New Delhi reserves rights to consider or reject any application/candidature. Submission of wrong or false information during the process of selection shall disqualify the candidature at any stage.
13. The persons engaged on Project Human Resource Positions shall not have any claim on a regular post in ICMR or in any of its Institutes/Centres or in any Department of Government of India and their project term with breaks or without breaks in any or multiple projects will not confer any right for further assignment or transfer to any other project or appointment / absorption / regularization of service in funding agency or in ICMR.
