Review and report all chest X-Ray images as per survey protocoland SOP in a time bound manner. Identify other medical conditions as well as the triage by coordinating with the local health facilities as well as referral to higher centers as and when necessary. Establishing coordination and support from local health facilities Visit all the survey sites for staff training and monitoring of survey activities.

- **6.** For reserved category posts, candidates must produce their latest Caste Validity Certificate. OBC candidates must possess a latest valid non-creamy layer certificate. PWD candidates shall produce latest disability certificate issued by a Medical board of Government hospital with not less than 40% disability.
- **7.** Age relaxation is admissible in respect of SC/ST/OBC candidates, Retrenched Government Employees, Departmental Candidates (including projects) and Ex-Servicemen in accordance with the instructions issued by the Central Government from time to time. Age concession to the extent of service rendered in other ICMR research projects will also be admissible for experienced and skilled persons.
