- **Consolidated fee/ Remuneration**: Rs.42,000/- per month. No House Rent Allowance (HRA) will be paid to the Young Professionals.
- 7. **Period of Engagement**. The initial term of engagement of will be for Young Professionals-II (F&A/Technical/Scientific/IT/Eng./Legal) one year which is extendable for two more years (01 year at a time) subject to requirement of services of Young Professional in the organization and satisfactory performance of the candidates after evaluation by an officer of the level of Additional DG/Sr.DDG/Sr.F.A. The maximum duration of engagement of Young Professionals in NIRDH & DS is three years in any case.

- iv) Short listing of candidates for interview shall be done on basis of educational qualification and experience. However, if necessary, written test and assignment may also be conducted before the interview.
