Subject:- Amendment of Health Research Scientist Cadre Rules 2007 – for the post of Additional Director General in the Pay Matrix Level-15 (Rs. 182200-224100)

I am directed to refer to this office letter No. 6/15/2003-Admn.II (Part) dated 11.09.2020, on the subject mentioned above. The Hon'ble HFM, being the President of the Governing Council of ICMR has approved the amendment in the R & D experience of the existing ICMR HRSC Rules 2007, for the post of Additional Director General in the Pay Matrix Level-15 (Rs. 182200-224100), as below:

***In case applicants are from Private Sector or Laboratories/Institutions abroad, the Screening Committee shall decide the equivalency of Pay Scale.
