TERMS & CONDITIONS

1. Tender (Two Cover bid – Technical Bid and Financial Bid, together in a big envelope) should reach ICMR-National Institute for Research in Reproductive and Child Health, Jehangir Merwanji Street, Parel, Mumbai 400012, Maharashtra before the prescribed date and time mentioned in the Tender.
2. The bidder should be authorized by the OEM and should submit MAF Certificate for this Bid.
3. The tender document should be super scribing “Tender No. B/13030/11/2024-25/MCBL dated 29th July 2024 for supply of Computer Workstations – 2 No.s; Due Date: 19th August 2024”
3. The tender not submitted as per the above prescribed manner will be treated as invalid. All outstation tenders should be sent to so as to reach before the prescribed time limit. Late/delayed Tenders shall not be considered under any circumstances.
4. Tender should be accompanied by an undertaking wherein it may be stated that ‘If they withdraw or modify their bid/s during period of validity etc. they will be suspended as per the directions of competent authority of the Institute’. The offer without Undertaking would be summarily rejected.
5. The last date for receipt of tenders in NIRRH is 19th August 2024 up to 17.00 hrs. The offers received would be verified on 21st August 2024 at 11.00 hrs.
6. The successful tenderers will have to submit Demand Draft / Bank Guarantee in favour of Director, NIRRH, equivalent to 5% of the order value/contract cost (towards security of performance), which will be retained till 06 months after the completion of work / contract. The successful bidder is liable to replace / carry out work if any deficiency / deviation found upto 06 months after completion of the work.
7. The Director reserves the right to exempt from said submission in case of low value orders.
8. The Director, NIRRH, reserves the right to call for break-up of the quotation if it is found necessary. Incomplete specifications offered by the tenderer(s) will not be considered and are liable to be rejected.
9. The offers should be kept valid for acceptance for a period up to 31st October 2024.
10. The payment will be arranged as per extant Government Rules and Regulations or 04 weeks.
11. The tendered price should be quoted as the basic cost, without taxes and duties which may be indicated separately.
12. Conditional offers will not be accepted and liable to be rejected without any further

reference.

13. The Director, ICMR-National Institute for Research in Reproductive and Child Health (NIRRCH), Mumbai reserves the rights to accept or reject any lowest tender in full or in part of any tender or all tenders without assigning any reasons.

14. Warranty period of the supplied products shall be 3 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid.

15. Bidder / OEM has to give an undertaking that after expiry of warranty period, it will provide AMC Service for next 2 years for the offered products at the rate not more than 5 % of contract price per annum. Buyer reserves the right to enter into an AMC agreement (covering preventive maintenance and servicing) with the Successful Bidder / OEM after expiry of the Warranty period at rate as mentioned above and the payment for the AMC charges would be made Biannually after rendering of the AMC Services of the relevant AMC period. Performance Security of the successful bidder shall be forfeited if it fails to accept the AMC contract when called upon by the buyer. The original Performance Security of contract will be returned only after submission and verification of AMC Performance Security for 10% of total AMC value valid up to AMC period plus 2 months (if there is no other claim). (Undertaking of acceptance is to be submitted along with bid)

16. Delivery of the Computer Work Station(s) should be completed within 28 days from the date of placing the Order / Contract. Installation / Commissioning of the Computer Work station(s) should be completed within 07 days of delivery of the work station(s).

17. Any of the disputes if arise between the Supplier/Tenderer and the NIRRCH/ICMR shall be resolved by the sole arbitrator which will be appointed by mutual consent of both the parties thereof failing which one of the Director of other Institute of ICMR ICMR – NIRRCH Tender No. B/13030/11/2024-25/MCBL dated 29th July 2024 for supply of Computer Workstations – 2 No.s in Mumbai (NIIH or NIV) shall be appointed within 30 days from the date of cause of action of dispute and the award as may be given by the sole arbitrator shall be binding on both the parties within the Civil Jurisdiction of Hon'ble High Court of Bombay.
