- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. If the bidder wants to avail themselves of the

Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. - 2. The OEM Must have own manufacturing unit (attach the factory license) and servic e setup, Service support team to attend the service within 1-2 days.
- 3. Supplier must offer IS certified and standard products for the furniture materials, fi ttings and fixtures wherever applicable.
- 4. All wood components in the structure should be given anti-termite treatment befor e use.
- 5. The offer without technical details and drawings will not be accepted.
- 6. All the items should be made as per specifications provided with tender.
- 7. All available color schemes catalogue is to be submitted for approval by the agenc y for finalizations.
- 8. Supplier should get approval of scope of products before taking up execution of the work and further process for completion of the work.
- 9. The furniture locks provided shall be of reputed brand and have at least two set of keys.
- 10. The supplier should inform to purchaser about 7 days in advance before planning the installations.
- 11. The vendor must submit the list the addresses of clients for which they have sup plied similar kind of items with the name and contact number of the purchasers.
- 12. Workshop inspection may be done at supplier site before fixing sun-mica and poli shing the products and other furniture works.
- 13. Warranty of 12 months from date of receipt and final acceptance of the material must be provided by the supplier.
- 14. Pre-dispatch Inspection may be done at supplier site before packing the products for delivery to Institute site.
- 15. Supplier shall quote for all the parts; part quotation shall not be acceptable.
- 16. The supplier should have ISO 9001, ISO 14001 and ISO 45001 certification and submit the certificates along with the bid.
- 17. All certificate submitted by the bidder must be genuine. If certificates are found f alse /forged, bidder will be debarred for participating in all tendering process.
- 18. All information and requisite certificates stated above should be enclosed along

with quotation.

- 19. The products offered by the supplier should provide BIFMA certification or any oth er relevant documents agency to be submitted along with the bid.
- 20. The company should adhere strictly to the specification of all items such as pretreatment and powder coating processes wherever applicable and submits us the test certificates.
- 21. The company should be in a position to supply the materials within the stipulated time mentioned in the purchase order.
- 22. Bidder may request to visit the office /site where furniture is to be installed to have a proper idea about the requirement.
- 23. The Manufacturer Agency/Firm will have its own factory for metal and wood work ing. Complete detail of manufacturer unit must be technical capabilities to be accomplish desired job complete details to accomplish of required furniture mentioned in te nder along with machinery equipment/ tools & photographs. - 24. Supplier has to supply, install, commission and integrate all above listed items in a proper manner at the user's site, Mumbai, India
- 25. Supplier has to demonstrate the full functioning of all items as per the specificati ons. Ensured that all good quality and certified materials shall be used in order to me et the safety criterion.
- 26. Photographs showing raw materials and finished goods of test similar nature to be submitted along with bid. The Design & shop drawing of furniture mentioned in the tender document. The seller should guarantee the rectification of goods in case of any break down during the guarantee period.
