8. Bidders are bound to accept the orders accordingly.

## 2. Forms of EMD and PBG

1. Tender Inviting Authority: This tender enquiry for procurement of 252 kits of "ARC HBsAg QUAL II RGT 2 000 Tests List No. 2G22-35" is being invited by the Director General, Indian Council of Medical Research, A nsari Nagar, New Delhi to be supplied at the ICMR-NITVAR, Pune.

2. Interested bidders are required to sign "Bid Security Declaration" accepting that if they withdraw or mod ify their Bids during the period of validity, or if they are awarded the contract and they fail to sign the contr act, or to submit a performance security before the deadline defined in the request forbids document, they will be suspended for the period of 6 months from being eligible to submit Bids for contracts with the entity that invited the Bids.

3. Eligibility: The Bidder must be a Manufacturer or its authorized Agent.

4. One Bid per Bidder: A firm shall submit only one bid either individually or as a partner of a joint venture. A firm that submits either individually or, as a member of a joint venture, more than one bid will cause all t he proposals with the firms' participation to be disqualified.

5. ICMR reserves the right to cancel the bid in part or full without assigning any reason and liability on the buyer. On such cancellation the decision of the DG, ICMR will be binding and final on the subject.

6. Inspections and Tests: ICMR or its representative shall have the right to inspect and/or to test the Goods to confirm their conformity to the Contract specifications. Further, The Supplier may have an independent quality test conducted and the cost of such tests will be borne by the Supplier. b. Inspection of goods shall be carried out by representative of ICMR and they will issue an acceptance certificate.

7. Packing: (a) The Supplier shall provide such packing of the Goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the Contract. The packing shall be s ufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperat ures, salt, and precipitation during transit and open storage. Packing case size and weights shall take into consideration, where appropriate, the remoteness of the Goods, final destination and the absence of heavy handling facilities at all points in transit (b) The packing, marking, and documentation within and outside t he packages shall comply strictly with such special requirements as shall be expressly provided for in the Contract, including additional requirements strictly as per Technical Specifications, and in any subsequent instructions ordered by the Procurement agency. (c) Packing and Marking shall be strictly as per Technical Specifications and will be inspected in terms of provisions of specifications before clearing for dispatch.

8. Payment: 100% payment shall be made by ICMR-NITVAR, Pune after the receipt of complete goods in g ood condition, acceptance of goods and subject to submission of Performance Bank Guarantee. Payment fo r 78 kits is to be made from "HSS-HRG" and remaining 174 kits from "NFHS-6" project. This payment is sub ject to recoveries, if any, either on account of statutory deduction/ taxes/ Liquidated Damages, if any and non-rectification of defects/ deficiencies not attended by the Supplier or otherwise. The firm is required to submit the following documents to ICMR-NITVAR, Pune for payment:

9. Settlement of Disputes: (a) If any dispute or difference of any kind whatsoever shall arise between the P

(b) If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the Procurement agency or the Supplier may give notice to the other party of its intention to commence ar bitration, as hereinafter provided, as to the matter in dispute, and no arbitration in respect of this matter may be commenced unless such notice is given. (c) Any dispute or difference in respect of which a notice of intention to commence arbitration has been given in accordance with this Clause shall be finally settled by arbitration. Arbitration may be commenced prior to or after delivery of the Goods under the Contract. In the case of a dispute or difference arising between the Purchaser/Consignee and a domestic Supplier relati ng to any matter arising out of or connected with the contract, such dispute or difference shall be referred to the sole arbitrator appointed by Director General ICMR. (d) Arbitration proceedings shall be conducted i n accordance with the rules of procedure which are as follows. (i) The venue of Arbitration shall be the plac e from where the contract is issued and the language of the arbitration proceedings and that of all councils and communications between the parties shall be English. (ii) The decision of the majority of arbitrators sh all be final and binding upon parties. (iii) Settlement of disputes through pre-institution mediation and settl ement in accordance with the commercial courts, commercial division and commercial appellate division o f High Courts (Amendment) Act 2018, No. 28 of 2018 Chapter IIIA. (e) Settlement of Disputes: Notwithstan ding any reference to arbitration herein, a. the parties shall continue to perform their respective obligation s under the Contract unless they otherwise agree; and b. 11. Insurance: Unless otherwise instructed, the supplier shall make arrangements for insuring the goods a gainst loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the following manner: (a) In case of supply of goods on Consignee site basis, the supplier shall be responsible t ill the entire stores contracted for arrival in good condition at destination. The transit risk in this respect sh all be covered by the Supplier by getting the stores duly insured. The insurance cover shall be obtained by the Supplier and should be valid till 3 months after the receipt of goods by the Consignee. (b) If the goods i s not commissioned and handed over to the consignee within 3 months, the insurance will be got extended by the Supplier at their cost till the handing over of the goods to the consignee. 12. If the supplier fails to deliver any or all of the goods or fails to perform the services within the time fra me(s) incorporated in the contract, the purchaser/consignee shall, without prejudice to other rights and re medies available to the purchaser/consignee under the contract, deduct from the contract price, as liquidit y damages, calculated individually on each delayed performance of the contract including delivery, non-su bmission of documents, etc. a sum equivalent to 0.5% per week of delay or part thereof until actual deliver y or performance subject to a maximum of 10% of the contract price.
