- 1. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents. 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. #### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Generic

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

#### 3. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

#### 4. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

#### 5. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

### 6. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Account Payee Demand Draft also (besides PBG which is allowed as per GeM GTC). DD should be made in favour of

Director General, ICMR payable at New Delhi

. After award of contract, Successful Bidder can upload scanned copy of the DD in place of PBG and has to ensure delivery of hard copy to the original DD to the Buyer within 15 days of award of contract.

#### 7. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Fixed Deposit Receipt also (besides PBG which is allowed as per GeM GTC). FDR should be made out or pledged in the name of

A/C (Name of the Seller). The bank should certify on it that the deposit can be withdrawn only on the demand or with the sanction of the pledgee. For release of Security Deposit, the FDR will be released in favour of bidder by the Buyer after making endorsement on the back of the FDR duly signed and stamped along with covering letter. Successful Bidder has to upload scanned copy of the FDR document in place of PBG and has to ensure delivery of hard copy of Original FDR to the Buyer within 15 days of award of contract.

#### 8. Buyer Added Bid Specific ATC

- 1. Service provider should be a registered Chartered Accountant firm. Service provider should submit docu mentary evidence clearly indicating the Registration Number of the firm.
- 2. The Registered Office or one of the Branch Office of the service provider must be located in Delhi, NCR. Form-C/ Registration Certificate should be submitted as documentary proof.
- 3. Working hours will be as per norms.
- 4. The consent of buyer is necessary before removing any manpower.
- 5. (a) Bank statement indicating payment made to individual manpower to be provided along with each in voice. (b) No payment shall be made in advance nor any loan from any bank or financial institution recom mended on the basis of the order of award of work. (c) The service provider shall pay to the employee before the expiry of the seventh day of the following month and raise invoice to buyer (ICMR) after releasing the payment to manpower.
- 6. Payment to the service provider will be made directly by the ICMR Hqrs.

#### 7. PAYMENT TERMS

- 7.1 Payment Condition: (a) The quoted Service Charge shall be inclusive of GST and cover all statuary ded uction like EPF, ESI, etc, as applicable. (b) The Payment shall be made as per the financial quotes submitte d by the Service Provider and accepted by the Buyer. (c) Each monthly bill must accompany the copies of authenticated documents of payment of such contributions of EPF, ESIC, etc, as applicable. (d) Fixed mont hly consolidated remuneration (INR) exclusive of GST is Rs. 1 Lakh per Consultant.
- 7.2 Payment Cycle: (a) Payment shall be made once the services are delivered, and the Service Provider s ubmits the invoice for the same. (b) The Buyer shall make the payment within prescribed timelines as per t he payment process flow upon submission of invoice, logbook and service feedback.
- 7.3 Payment Process: (a) Payment shall be made only after submission of invoices, attendance sheet, logb ook, service feedback, non-submission of the same may lead to delay/ deduction in payment. (b) All the pe nalties/ fine/ interest (if applicable) shall be settled before making the payments. Service Provider shall not have any objection on the same. (c) Payment shall be made through bank transfer only, in no circumstance cash/ cheque payment shall be made.
- 8. Bid offering service charges of less than 3.85% (incl GST and cover all statuary deduction like EPF, ESI, e tc, as applicable) will be rejected. ICMR will not entertain any representation/ justification submitted by the bidders in this regard at the financial evaluation stage.
- 9. The Bidder must have successfully executed/ completed at least one single order of Rs. 94 Lakh or 2 ord ers each of Rs. 59 Lakh or 3 orders each of 40% of the Rs. 47 Lakh for similar service(s) in last three years (FY 2021-22, 2022-23 & 2023-24) to any Central/ State Govt Organization/ PSU/ Autonomous Bodies. Copies of Contracts/ Work Order and documentary evidence of successful execution/ completion in support of Past Experience of Similar Services along with names, address and contact details of clients shall be u ploaded with the bid for verification by the Buyer.
- 10. The Service Provider should supply and install atleast 01 Biometric attendance system in ICMR Hqrs., N ew Delhi at its own cost to record the attendance of the manpower provided.

- 11. 04 Consultants are to be deployed at ICMR Hqrs., New Delhi and 01 Consultant at ICMR-NIMR, New Delhi
- 12. Bidders may note that the following are attached separately and uploaded in the Buyer Uploaded ATC documents that are mandatory to be submitted at the bid stage strictly as per the prescribed format:
- (a) Undertaking by the bidder(s)
- (b) Proforma for declaration on court receivership/ liquidation/ blacklisted
- (c) Bidder(s) profile
- (d) Format of bid security declaration from bidders in lieu of EMD
- 13. Minimum Experience of Consultants/ Resources: 3 years
- 14. Maximum 8 leaves will be accorded in a year except Saturday/ Sunday and Govt. holidays. Leave record should be maintained by the service provider. If required, ICMR may ask the Consultants to come the of fice on Saturday/ Sunday. In lieu of this no extra remuneration will be provided only compensatory leave may be granted.
- 15. If deputed for official duty, TA/DA will be provided as per GOI/ICMR rules (Equivalent to Level-10 of 6th CPC).
- 16. Parameters/ Technical Specification/ T&C mentioned in the Buyer Added text based ATC shall prevail o ver GeM Bid Details/ Technical Specification/ General T&C.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.

- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.

- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
